19	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20	That the Laws of Maryland read as follows:
21	Article – Transportation
22	22–609.
23	(a) A person may not modify the exhaust system or any other noise abatement
24	device of a motor vehicle driven or to be driven on any highway in this State in such a way



- that the noise emitted by the vehicle exceeds that emitted by the vehicle as originally manufactured.
- 3 (b) A person may not drive on any highway in this State a motor vehicle with an 4 exhaust system or noise abatement device modified in a way prohibited by subsection (a) of 5 this section.
- 6 (C) If A POLICE OFFICER OBSERVES THAT A MOTOR VEHICLE IS BEING 7 OPERATED IN VIOLATION OF SUBSECTION (B) OF THIS SECTION, THE POLICE 8 OFFICER MAY STOP THE MOTOR VEHICLE AND SHALL ISSUE A CITATION FOR THE 9 VIOLATION.

- 11 (a) A person who violates a provision of the Maryland Vehicle Law is guilty of a 12 misdemeanor unless the violation:
- 13 (1) Is a felony under the Maryland Vehicle Law; or
- 14 (2) Is punishable by a civil penalty under the applicable provision of the 15 Maryland Vehicle Law.
- 16 (b) Except as otherwise provided in the Maryland Vehicle Law, a person convicted of a misdemeanor for a violation of a provision of the Maryland Vehicle Law is subject to a 18 fine not exceeding \$500.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 20 October 1, 2023.
