CHAPTER _____

1 AN ACT concerning

2 **Vehicle Laws – Autonomous Vehicle Converters – Sale of Autonomous Vehicles**

3 FOR the purpose of authorizing an autonomous vehicle converter to sell, transfer, lease,
4 offer for sale, or resell a converted autonomous vehicle or a motor vehicle purchased
5 with the intent to convert the motor vehicle into a converted autonomous vehicle;
6 establishing that certain portions of this Act apply only to motor vehicles intended
7 for commercial or industrial use; prohibiting an autonomous vehicle converter from
8 holding certain occupational vehicle licenses issued under the Maryland Vehicle
9 Law; and generally relating to autonomous vehicle converters.

5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
6 That the Laws of Maryland read as follows:

7 **Article – Transportation**

8 15–101.

9 (a) In this title the following words have the meanings indicated.

10 (c) (3) “Dealer” does not include:

11 (i) A public official who sells or disposes of vehicles in the
12 performance of his official duties;

13 (ii) An insurance company, finance company, bank, or other lending
14 institution licensed or otherwise authorized to do business in this State that, to save it from
15 loss, sells or disposes of vehicles under a contractual right and in the regular course of its
16 business;

17 (iii) A licensed auctioneer acting on behalf of a seller, secured party
18 or owner and where title does not pass to the auctioneer and the auction is not for the
19 purpose of avoiding the provisions of this title;

20 (iv) A receiver, trustee, personal representative, or other person
21 appointed by or acting under the authority of any court;

22 (v) Either a manufacturer or distributor who sells or distributes
23 vehicles to licensed dealers or a person employed by a manufacturer or distributor to
24 promote the sale of the vehicles of the manufacturer or distributor, if that manufacturer,
25 distributor, or person does not sell vehicles to retail buyers;

26 (vi) A person who sells or disposes of vehicles acquired and used for
27 personal or business use and not for the purpose of avoiding the provisions of this title, if
28 that person is not engaged in buying, selling, or exchanging vehicles as a business;

29 (vii) An automotive dismantler and recycler who during the normal
30 course of business acquires a salvage vehicle and transfers the vehicle on a salvage
31 certificate. However, if the automotive dismantler and recycler rebuilds and sells more than
32 5 vehicles during a 12–month period to a person other than another automotive dismantler
33 and recycler or licensed dealer, the automotive dismantler and recycler must be licensed as
34 a dealer under § 15–302 of this title;

1 (viii) A person engaged in the leasing of motor vehicles under leases
2 not intended as security; [or]

3 (ix) A religious, charitable, or volunteer organization exempt from
4 taxation under § 501(c) of the Internal Revenue Code, the Department of Human Services,
5 or a local department of social services transferring a vehicle under § 13–810 of this article;
6 **OR**

7 **(X) AN AUTONOMOUS VEHICLE CONVERTER AS DEFINED IN §**
8 **15–901 OF THIS TITLE.**

9 15–201.

10 (a) In this subtitle the following words have the meanings indicated.

11 (b) **(1)** “Distributor” means a distributor who is authorized by the
12 manufacturer or the manufacturer’s authorized importer to enter into franchise
13 agreements with dealers of:

14 [(1)] **(I)** New motor vehicles constructed or assembled outside of the
15 United States; or

16 [(2)] **(II)** New two–stage vehicles completed outside of the United States
17 by a second–stage manufacturer.

18 **(2) “DISTRIBUTOR” DOES NOT INCLUDE AN AUTONOMOUS VEHICLE**
19 **CONVERTER AS DEFINED IN § 15–901 OF THIS TITLE.**

20 (c) **(1)** “Factory branch” means a branch office of a manufacturer from which
21 the manufacturer:

22 [(1)] **(I)** Sells or promotes the sale to dealers in this State of a particular
23 brand or make of new motor vehicles, or new completed two–stage vehicles;

24 [(2)] **(II)** Directs and supervises its representatives in this State; or

25 [(3)] **(III)** Supervises or contacts its dealers or prospective dealers in this
26 State.

27 **(2) “FACTORY BRANCH” DOES NOT INCLUDE AN AUTONOMOUS**
28 **VEHICLE CONVERTER AS DEFINED IN § 15–901 OF THIS TITLE.**

29 (d) “License” means a manufacturer’s, distributor’s, or factory branch’s license
30 issued by the Administration under this subtitle.

1 (e) (1) “Manufacturer” means:

2 [(1)] (I) A manufacturer of new motor vehicles constructed or assembled
3 in the United States;

4 [(2)] (II) A second-stage manufacturer of new two-stage vehicles
5 completed in the United States; and

6 [(3)] (III) In the case of trucks, a person engaged in the business of
7 manufacturing truck component parts.

8 (2) “MANUFACTURER” DOES NOT INCLUDE AN AUTONOMOUS
9 VEHICLE CONVERTER AS DEFINED IN § 15-901 OF THIS TITLE.

10 (f) “Second-stage manufacturer” has the meaning stated in § 13-113.2 of this
11 article.

12 **SUBTITLE 9. AUTONOMOUS VEHICLE CONVERTERS.**

13 **15-901.**

14 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS
15 INDICATED.

16 (B) “AUTOMATED DRIVING STANDARDS” MEANS THE SIX LEVELS OF
17 DRIVING AUTOMATION ESTABLISHED UNDER THE SAE INTERNATIONAL J3016
18 STANDARD.

19 (C) “AUTOMATED DRIVING SYSTEM” MEANS THE HARDWARE AND
20 SOFTWARE THAT ARE COLLECTIVELY CAPABLE OF PERFORMING PART OR ALL OF
21 THE DYNAMIC DRIVING TASK ON A SUSTAINED BASIS, REGARDLESS OF WHETHER
22 THE DRIVING TASK IS LIMITED TO A SPECIFIC OPERATIONAL DESIGN DOMAIN.

23 (D) “AUTONOMOUS VEHICLE CONVERTER” MEANS A PERSON THAT:

24 (1) ALTERS OR MODIFIES A NEW OR USED MOTOR VEHICLE BY
25 ADDITION, SUBSTITUTION, OR REMOVAL OF COMPONENTS, OTHER THAN READILY
26 ATTACHABLE COMPONENTS, IN COMPLIANCE WITH ALL APPLICABLE MOTOR
27 VEHICLE SAFETY REQUIREMENTS ESTABLISHED UNDER FEDERAL LAW; AND

28 (2) ASSEMBLES, INSTALLS, AND AFFIXES AN AUTOMATED DRIVING
29 SYSTEM TO A NEW OR USED MOTOR VEHICLE IN SUCH A MANNER THAT CONVERTS
30 THE VEHICLE INTO A CONVERTED AUTONOMOUS VEHICLE.

1 (E) "CONVERTED AUTONOMOUS VEHICLE" MEANS A MOTOR VEHICLE THAT:

2 (1) IS EQUIPPED WITH AN AFTERMARKET AUTOMATED DRIVING
3 SYSTEM CAPABLE OF OPERATING IN ACCORDANCE WITH SOME OR ALL OF THE
4 AUTOMATED DRIVING STANDARDS;

5 (2) MEETS OR EXCEEDS WEIGHT OR CAPACITY THRESHOLDS
6 ESTABLISHED UNDER FEDERAL LAW; AND

7 (3) IS CAPABLE OF OPERATING IN ACCORDANCE WITH APPLICABLE
8 STATE AND FEDERAL LAW.

9 (F) "OPERATIONAL DESIGN DOMAIN" MEANS OPERATING CONDITIONS
10 UNDER WHICH A GIVEN AUTOMATED DRIVING SYSTEM IS SPECIFICALLY DESIGNED
11 TO FUNCTION, INCLUDING CONDITIONS SUBJECT TO:

12 (1) ENVIRONMENTAL RESTRICTIONS;

13 (2) GEOGRAPHIC RESTRICTIONS;

14 (3) TIME-OF-DAY RESTRICTIONS; OR

15 (4) THE REQUIRED PRESENCE OR ABSENCE OF CERTAIN TRAFFIC OR
16 ROADWAY CHARACTERISTICS.

17 15-902.

18 THIS SUBTITLE APPLIES ONLY TO MOTOR VEHICLES INTENDED FOR
19 COMMERCIAL OR INDUSTRIAL USE.

20 15-903.

21 (A) NOTWITHSTANDING ANY OTHER PROVISION OF THIS ARTICLE, AN
22 AUTONOMOUS VEHICLE CONVERTER MAY SELL, TRANSFER, LEASE, OFFER FOR
23 SALE, OR RESELL:

24 (1) A CONVERTED AUTONOMOUS VEHICLE; OR

25 (2) A MOTOR VEHICLE PURCHASED BY AN AUTONOMOUS VEHICLE
26 CONVERTER WITH THE INTENT TO CONVERT THE MOTOR VEHICLE INTO A
27 CONVERTED AUTONOMOUS VEHICLE.

1 **(B) AN AUTONOMOUS VEHICLE CONVERTER MAY NOT BE LICENSED UNDER**
 2 **THIS TITLE AS A MANUFACTURER, DISTRIBUTOR, OR FACTORY BRANCH OR AS A**
 3 **DEALER.**

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
 5 1, 2023.
