- 3 (a) (1) Any individual who desires to obtain an original driver's license under 4 this subtitle or to be licensed in a class for which the individual is not already licensed 5 under this subtitle shall apply to the Administration for the desired driver's license.
- 6 (2) Except as provided in subsection (f) of this section, before issuing a 7 driver's license, the Administration shall issue to each applicant a learner's instructional 8 permit. The learner's instructional permit shall identify clearly the class of license for which 9 the applicant has applied.
- 10 (3) (i) Each applicant for a learner's instructional permit who is under 11 the age of 16 years shall present to the Administration a copy of the applicant's school 12 attendance record.
- 13 (ii) The Administration may not issue a learner's instructional 14 permit to an applicant under the age of 16 years if the applicant's school attendance record 15 indicates more than 10 unexcused absences during the prior school semester.
- 16 (e) (1) This subsection only applies to an individual who holds a license and 17 who seeks a different class license to drive a motor vehicle that, under the individual's 18 current license, the individual is not authorized to drive.
- 19 (2) The holder of a learner's instructional permit may not take the driver's license examination sooner than 14 days after the permit is issued.
- 21 (3) The 14 days' requirement may be waived if a subsequent learner's 22 instructional permit is issued or applied for.
- 23 (4) A learner's instructional permit issued to an individual described in 24 paragraph (1) of this subsection expires 180 days after date of issuance.
- 25 (5) A COMMERCIAL DRIVER'S INSTRUCTIONAL PERMIT ISSUED TO AN 26 INDIVIDUAL DESCRIBED IN PARAGRAPH (1) OF THIS SUBSECTION EXPIRES 1 YEAR 27 AFTER THE DATE OF ISSUANCE.

- 29 (i) (1) Except as provided in paragraphs (2) [and], (3), AND (5) of this 30 subsection, the Administration shall require every individual applying for renewal of a 31 driver's license to pass a vision test as prescribed by the Administration.
- 32 (2) (i) The Administration shall accept a certification of acceptable 33 visual acuity from a licensed physician or optometrist instead of requiring the actual test

provided for in this subsection.

2 3	(ii) The examination for which certification is made shall take place within 2 years of the date of application for renewal.
4 5 6 7	(3) An individual at least 21 years of age but under the age of 40 years may apply for renewal of a driver's license electronically or by mail or other means authorized by the Administration without taking a vision test if the applicant has passed a vision test authorized by the Administration within the previous 9 years.
8 9 10	(4) (i) If the Administration has reason to believe that an individual is a safety hazard by reason of a vision deficiency, the Administration may require the vision test provided for in this subsection at a time other than renewal of a driver's license.
11 12	(ii) The Administration may adopt regulations to implement the provisions of this subsection.
13 14 15 16 17	(5) AN INDIVIDUAL WHO HOLDS A COMMERCIAL DRIVER'S LICENSE AND APPLIES FOR RENEWAL IS EXEMPT FROM THE REQUIREMENT TO PASS A VISION TEST IF THE INDIVIDUAL HAS A CURRENT CERTIFICATE OF PHYSICAL EXAMINATION ON FILE WITH THE ADMINISTRATION, AS REQUIRED UNDER 49 C.F.R. §§ 391.43 AND 391.45.
