the Governor shall appoint members from among:

- 15 (1) the geographic regions of the State; and

- 17 (c) A majority of the members shall be individuals with disabilities.
- 18 (d) (1) The term of a member is 3 years.

19 (2) The terms of the members are staggered as required by the terms 20 provided for the members of the Commission on October 1, 2007.

21 (3) At the end of a term, a member continues to serve until a successor is 22 appointed and qualifies.

(4) A member who is appointed after a term has begun serves only for the
 rest of the term and until a successor is appointed and qualifies.

A member may not serve more than two consecutive 3-year terms.

(e) A member who fails to attend at least 50% of the regularly scheduled meetings
of the Commission during any 12–month period shall be considered to have resigned.

28 <u>SECTION 2. AND BE IT FURTHER ENACTED, That, as of July 1, 2023, the</u> 29 <u>Governor shall transfer two positions and the associated general funds for the State</u>

- 1 <u>Coordinator for Autism Strategy from the Executive Department to the Department of</u>
- 2 <u>Disabilities as specified under Section 1 of this Act.</u>
- 3 SECTION 2. 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
   4 October July 1, 2023.
