A BILL ENTITLED

1 AN ACT concerning

2 **Harford County – Alcoholic Beverages – Class L License**

3 FOR the purpose of establishing a Class L beer, wine, and liquor license in Harford County;
4 authorizing the Board of License Commissioners for Harford County to issue the
5 license to a holder of a manufacturer’s license; authorizing the license holder to hold
6 another license or permit issued by the Board; specifying that the license authorizes
7 the license holder to sell or provide samples of certain beer, wine, and liquor for
8 on–premises consumption under certain circumstances; requiring the license holder
9 to provide prepackaged snacks; providing for the hours of sale and an annual license
10 fee; requiring the retention of certain records for a certain period of time; and
11 generally relating to alcoholic beverages in Harford County.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
23 That the Laws of Maryland read as follows:

24 **Article – Alcoholic Beverages**

25 22–102.

3 **(A) THERE IS A CLASS L BEER, WINE, AND LIQUOR LICENSE.**

4 **(B) THE BOARD MAY ISSUE THE LICENSE TO THE HOLDER OF A**
5 **MANUFACTURER'S LICENSE.**

6 **(C) THE LICENSE HOLDER MAY HOLD ANOTHER LICENSE OR PERMIT**
7 **ISSUED BY THE BOARD TO SELL PRODUCTS THE HOLDER PRODUCES TO THE EXTENT**
8 **THE HOLDER IS AUTHORIZED UNDER THE HOLDER'S MANUFACTURER'S LICENSE.**

9 **(D) THE LICENSE AUTHORIZES THE LICENSE HOLDER, FOR ON-PREMISES**
10 **CONSUMPTION, TO:**

11 **(1) SELL BEER, WINE, AND LIQUOR:**

12 **(I) PRODUCED BY THE HOLDER OR ANOTHER HOLDER OF A**
13 **MANUFACTURER'S LICENSE ISSUED UNDER THIS ARTICLE AND HELD IN THE**
14 **COUNTY; AND**

15 **(II) THAT MAY BE MIXED WITH:**

16 **1. OTHER BEER, WINE, AND LIQUOR THAT IS PRODUCED**
17 **OR MANUFACTURED IN THE COUNTY; OR**

18 **2. NONALCOHOLIC PRODUCTS, REGARDLESS OF WHERE**
19 **THE NONALCOHOLIC PRODUCTS ARE PRODUCED OR MANUFACTURED; AND**

20 **(2) SUBJECT TO SUBSECTION (E) OF THIS SECTION, PROVIDE A**
21 **SAMPLE OF THE BEER, WINE, OR LIQUOR THAT IS AUTHORIZED UNDER ITEM (1) OF**
22 **THIS SUBSECTION AT NO COST.**

23 **(E) (1) THE LICENSE HOLDER MAY PROVIDE TO A CONSUMER NOT MORE**
24 **THAN SIX OFFERINGS IN 1 DAY OF A SAMPLE OF BEER, WINE, OR LIQUOR COVERED**
25 **BY THE LICENSE.**

26 **(2) A SAMPLE QUANTITY MAY NOT EXCEED:**

27 **(I) 3 OUNCES FROM EACH OFFERING OF BEER;**

28 **(II) 2 OUNCES FROM EACH OFFERING OF WINE; OR**

1 **(III) 1 OUNCE FROM EACH OFFERING OF LIQUOR.**

2 **(3) THE LICENSE HOLDER MAY NOT PROVIDE MORE THAN TWO**
3 **OFFERINGS OF A SAMPLE OF LIQUOR IN A SINGLE DAY TO THE SAME CONSUMER.**

4 **(F) THE LICENSE HOLDER SHALL RETAIN, FOR 2 YEARS AFTER THE DATE OF**
5 **PURCHASE, INVOICES AND ANY RECORDS OF THE PURCHASE OF ANY ALCOHOLIC**
6 **BEVERAGE PRODUCT NOT MANUFACTURED BY THE LICENSE HOLDER.**

7 **(G) THE LICENSE HOLDER IS NOT REQUIRED TO SELL FOOD BUT IS**
8 **REQUIRED TO PROVIDE PREPACKAGED SNACKS.**

9 **(H) THE HOURS OF SALE FOR A CLASS L BEER, WINE, AND LIQUOR LICENSE**
10 **ARE THE SAME AS THOSE FOR THE UNDERLYING MANUFACTURER'S LICENSE.**

11 **(I) THE ANNUAL LICENSE FEE IS \$3,000.**

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
13 1, 2023.
