- 7 (A) IN THIS SECTION, "PERFORMING ARTS THEATER" MEANS AN AREA, A
- 8 BUILDING, OR A STRUCTURE DESIGNED AND USED FOR PLAYS, ACTS, DRAMAS,
- 9 CONCERTS, OR HISTRIONICS BY ACTORS OR ACTRESSES PERFORMING ON A STAGE
- 10 OR THE SHOWING OF MOVIES OR FILMS.
- 11 (B) THERE IS A PERFORMING ARTS THEATER BEER AND WINE LICENSE.
- 12 (C) THE BOARD MAY ISSUE THE LICENSE FOR USE ON THE PREMISES OF A
- 13 PERFORMING ARTS THEATER OPERATED BY A NONPROFIT ORGANIZATION.
- 14 (D) THE LICENSE AUTHORIZES THE HOLDER TO SELL OR SERVE BEER AND
- 15 WINE AT RETAIL FOR ON-PREMISES CONSUMPTION.
- 16 (E) THE LICENSE HOLDER MAY SELL OR SERVE BEER AND WINE:
- 17 (1) 1 HOUR BEFORE AND AFTER A PERFORMANCE;
- 18 (2) DURING A PERFORMANCE;
- 19 (3) DURING AN INTERMISSION; AND
- 20 (4) DURING A CAST PARTY OR RECEPTION BEFORE OR AFTER A
- 21 PERFORMANCE.
- 22 (F) THE LICENSE MAY NOT BE TRANSFERRED TO ANOTHER LOCATION.
- 23 (G) THE LICENSE HOLDER SHALL PURCHASE BEER AND WINE FROM A
- 24 RETAIL LICENSE HOLDER OR AN AUTHORIZED AND LICENSED WHOLESALER OR
- 25 MANUFACTURER.
- 26 (H) ISSUANCE OF A LICENSE UNDER THIS SECTION DOES NOT PROHIBIT THE
- 27 BOARD FROM ISSUING A CLASS C PER DIEM LICENSE THAT APPLIES TO THE
- 28 PERFORMING ARTS THEATER.

- 1 (I) THE LICENSE HOLDER SHALL SERVE OR OFFER FOR SALE SNACKS AT 2 ALL TIMES WHEN BEER AND WINE ARE SOLD.
- 3 (J) THE ANNUAL LICENSE FEE IS \$500.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July  $5-1,\,2023.$
