12(2) ANY APPLIANCE CONTAINING THE REFRIGERANT DESIGNATED13FOR ACCEPTABLE USE IS LABELED, INSTALLED, SERVICED, REPAIRED, USED, AND14DISPOSED OF INSTALLED AND USED IN ACCORDANCE WITH THE SAFETY STANDARDS15AND USE CONDITIONS UNDER 42 U.S.C. 7671K.

16(C)THIS SECTION DOES NOT PROHIBIT THE DEPARTMENT OF THE17ENVIRONMENT FROM ADOPTING REGULATIONS THAT PROHIBIT THE USE OF A18REFRIGERANT.
