A BILL ENTITLED

1 AN ACT concerning

Vehicle Laws – Military Vehicles – Registration and Operation

FOR the purpose of authorizing the Motor Vehicle Administration to register certain 3 military vehicles; providing for the registration classification of military vehicles; 4 $\mathbf{5}$ establishing certain standards and procedures for the registration of military 6 vehicles; requiring an owner of a military vehicle to submit with the registration 7 application a certain certification relating to the purposes for which the vehicle will 8 be operated; requiring the Administration, in consultation with certain persons, to 9 develop a safety inspection and a safety inspection process for military vehicles; and generally relating to the registration and operation of military vehicles. 10

22 (1) WAS MANUFACTURED FOR MILITARY USE BY OR UNDER THE 23 DIRECTION OF THE UNITED STATES ARMED FORCES OR THE ARMED FORCES OF 24 ANOTHER COUNTRY;
