- 3 FOR the purpose of authorizing the Motor Vehicle Administration to register certain military vehicles; providing for the registration classification of military vehicles; 4 5 establishing certain standards and procedures for the registration of military 6 vehicles; requiring an owner of a military vehicle to submit with the registration 7 application a certain certification relating to the purposes for which the vehicle will be operated; requiring the Administration, in consultation with certain persons, to 8 9 develop a safety inspection and a safety inspection process for military vehicles; and 10 generally relating to the registration and operation of military vehicles.
