- 10 (I) MAINTAIN COMMERCIAL GENERAL LIABILITY INSURANCE, 11 INCLUDING ERRORS AND OMISSIONS AND COMPLETED OPERATIONS WITH A 12 \$500,000 TOTAL AGGREGATE MINIMUM; AND
- 13 (II) SUBMIT PROOF OF THE REQUIRED INSURANCE TO THE 14 SECRETARY.
- 15 (b) (1) If an applicant for a license **OR A SECURITY GUARD EMPLOYER**16 intends to employ [five] **ONE** or more individuals as security guards, the applicant shall
 17 submit proof of the liability insurance required under subsection (a) of this section to the
 18 Secretary with the license application.
- 19 (2) (I) The Secretary may not issue a license to an applicant to whom 20 the insurance requirements of this section would apply unless the applicant submits proof 21 of the insurance.
- 22 (II) THE SECRETARY MAY NOT AUTHORIZE THE CERTIFICATION 23 OF A SECURITY GUARD FOR A SECURITY GUARD EMPLOYER UNLESS THE SECURITY 24 GUARD EMPLOYER SUBMITS PROOF OF APPLICABLE INSURANCE UNDER 25 SUBSECTION (A) OF THIS SECTION.
- 26 (c) If the insurance required for a security guard agency **OR SECURITY GUARD**27 **EMPLOYER** under this section is canceled, forfeited, or otherwise terminated, both the
 28 security guard agency **OR THE SECURITY GUARD EMPLOYER** and the insurer shall notify
 29 the Secretary.
- 30 (d) If a security guard agency fails to maintain the liability insurance required 31 under this section, the license of the security guard agency:
 - (1) is suspended automatically;

- 1 (2) shall remain suspended until the agency complies with the 2 requirements; and
- 3 (3) may not be reinstated until the agency submits proof of the required 4 insurance to the Secretary.
- 5 (E) IF A SECURITY GUARD EMPLOYER FAILS TO MAINTAIN THE LIABILITY
 6 INSURANCE REQUIRED UNDER THIS SECTION, THE SECRETARY MAY PROHIBIT A
 7 SECURITY GUARD EMPLOYER FROM EMPLOYING A CERTIFIED SECURITY GUARD
 8 UNTIL THE SECURITY GUARD EMPLOYER:
- 9 (1) COMPLIES WITH THE APPLICABLE INSURANCE REQUIREMENTS 10 UNDER SUBSECTION (A) OF THIS SECTION; AND
- 11 (2) SUBMITS PROOF OF THE REQUIRED INSURANCE TO THE 12 SECRETARY.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2024.
