A BILL ENTITLED

1 AN ACT concerning

Election Reform Act of 2023

3 FOR the purpose of prohibiting a person from knowingly and willfully making a threat to take the life of, kidnap, or cause physical injury to a county election director; 4 $\mathbf{5}$ establishing requirements and prohibitions related to a contract with an election 6 service provider; authorizing the State Administrator of Elections to terminate, in 7 whole or in part, a contract with an election service provider under certain 8 circumstances; requiring judges of the circuit courts to be elected on a nonpartisan 9 basis; establishing procedures for the nomination and election of circuit court judges on a nonpartisan basis; prohibiting a stray mark, blemish, or writing from being the 1011 sole basis for invalidating a ballot under certain circumstances; limiting the 12individuals to whom a local board of elections may provide an absentee ballot 13 through the Internet; requiring a contractor who is responsible for distributing 14 absentee ballots to voters to mail the ballots in a certain manner but not later than 15a certain number of days before the election; altering the procedures for the selection, 16voting, certification, and meetings of presidential electors; providing that 17presidential electors who take certain actions vacate the office; requiring the State 18 Board of Elections to develop strategies and inform voters about casting absentee 19ballots by mail and requesting Internet ballots; requiring the State Board to analyze 20data on the reasons voters cast provisional ballots; and generally relating to the 21 administration of elections.
