1 AN ACT concerning

2 Vehicle Laws – Special and Commemorative Registration Plate – Maryland Heroes

- FOR the purpose of requiring the Motor Vehicle Administration, in consultation with the 4 5 Maryland Commission on African American History and Culture, to design and issue 6 a Maryland Heroes registration plate that features the images of Harriet Tubman 7 and Frederick Douglass; requiring the Motor Vehicle Administration to charge 8 certain additional registration fees related to the issuance and renewal of the 9 Maryland Heroes registration plate and to distribute revenue from the additional registration fees in a certain manner; and generally relating to the specially designed 10 Maryland Heroes Commemorative Registration Plate. 11
