13 14 15 16 17	(a) Unless the Board agrees to accept the surrender of a license, a licensed social worker OR THE HOLDER OF A TEMPORARY LICENSE may not surrender the license nor may the license lapse by operation of law while the licensee is under investigation or while charges are pending against the social worker.

AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three—fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
