A BILL ENTITLED

1 AN ACT concerning

2 **State Procurement – Preferences – Historically Underutilized Business Zone**
3 **Businesses**

4 FOR the purpose of requiring a unit to structure procurement procedures to try to achieve
5 or exceed a certain overall percentage goal of the unit's total dollar value of
6 procurement contracts to be made directly or indirectly with historically
7 underutilized business zone businesses certified by the U.S. Small Business
8 Administration; providing for the determination of expected historically
9 underutilized business zone business participation for individual solicitations;
10 establishing certain methods for the award of contracts that meet or make a good
11 faith effort to meet the percentage goal for historically underutilized business zone
12 businesses; establishing certain penalties; including certain historically
13 underutilized business zone businesses in the Small Business Reserve Program; and
14 generally relating to procurement preferences for historically underutilized business
15 zone businesses.

27 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
28 That the Laws of Maryland read as follows:

1 2. A. the gross sales of the wholesale operations of the
2 business did not exceed an average of \$4,000,000 in its most recently completed 3 fiscal
3 years;

4 B. the gross sales of the retail operations of the business did
5 not exceed an average of \$3,000,000 in its most recently completed 3 fiscal years;

6 C. the gross sales of the manufacturing operations of the
7 business did not exceed an average of \$2,000,000 in its most recently completed 3 fiscal
8 years;

9 D. the gross sales of the service operations of the business did
10 not exceed an average of \$10,000,000 in its most recently completed 3 fiscal years;

11 E. the gross sales of the construction operations of the
12 business did not exceed an average of \$7,000,000 in its most recently completed 3 fiscal
13 years; and

14 F. the gross sales of the architectural and engineering
15 services of the business did not exceed an average of \$4,500,000 in its most recently
16 completed 3 fiscal years.

17 (c) “Small business reserve” means those procurements that are limited to
18 responses from small businesses under § 14–502(b) of this subtitle.

19 **SUBTITLE 8. HISTORICALLY UNDERUTILIZED BUSINESS ZONE BUSINESS**
20 **PARTICIPATION.**

21 **14–801.**

22 **IN THIS SUBTITLE, “HISTORICALLY UNDERUTILIZED BUSINESS ZONE**
23 **BUSINESS” MEANS A BUSINESS THAT MEETS THE STANDARDS ADOPTED BY THE U.S.**
24 **SMALL BUSINESS ADMINISTRATION IN 13 C.F.R. 126, SUBPART B AND ANY**
25 **SUBSEQUENT REVISION OF THAT REGULATION.**

26 **14–802.**

27 **(A) (1) A UNIT SHALL STRUCTURE PROCUREMENT PROCEDURES,**
28 **CONSISTENT WITH THE PURPOSES OF THIS SUBTITLE, TO TRY TO ACHIEVE OR**
29 **EXCEED AN OVERALL PERCENTAGE GOAL OF THE UNIT’S TOTAL DOLLAR VALUE OF**
30 **PROCUREMENT CONTRACTS TO BE MADE DIRECTLY OR INDIRECTLY WITH**
31 **HISTORICALLY UNDERUTILIZED BUSINESS ZONE BUSINESSES.**

1 **(2) (I) SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, THE**
2 **GOVERNOR'S OFFICE OF SMALL, MINORITY, AND WOMEN BUSINESS AFFAIRS**
3 **SHALL ADOPT REGULATIONS THAT ESTABLISH THE OVERALL PERCENTAGE GOAL.**

4 **(II) THE OVERALL PERCENTAGE GOAL SHALL BE AT LEAST 10%.**

5 **(B) SOLICITATION DOCUMENTS SHALL STATE THE EXPECTED PERCENTAGE**
6 **OF HISTORICALLY UNDERUTILIZED BUSINESS ZONE BUSINESS PARTICIPATION**
7 **BASED, IN PART, ON:**

8 **(1) THE POTENTIAL CONTRACTING OPPORTUNITIES AVAILABLE IN**
9 **THE PROCUREMENT CONTRACT, INCLUDING BOTH PRIME CONTRACTING AND**
10 **SUBCONTRACTING OPPORTUNITIES, AS DETERMINED THROUGH ANALYSIS OF THE**
11 **SCOPE OF THE WORK PRESENTED IN THE SOLICITATION DOCUMENTS; AND**

12 **(2) THE AVAILABILITY OF HISTORICALLY UNDERUTILIZED BUSINESS**
13 **ZONE BUSINESSES TO RESPOND COMPETITIVELY TO THE POTENTIAL CONTRACTING**
14 **OPPORTUNITIES.**

15 **(C) THE PROVISIONS OF THIS SUBTITLE DO NOT APPLY TO A UNIT'S**
16 **PROCUREMENT PROCEDURES TO THE EXTENT THAT ANY UNIT DETERMINES THAT**
17 **THOSE PROVISIONS ARE IN CONFLICT WITH AN APPLICABLE FEDERAL PROGRAM.**

18 **14-803.**

19 **(A) FOR PROCUREMENTS CONDUCTED BY COMPETITIVE SEALED BIDDING,**
20 **A UNIT SHALL AWARD THE CONTRACT TO THE RESPONSIBLE BIDDER THAT SUBMITS**
21 **THE RESPONSIVE BID THAT:**

22 **(1) (I) HAS THE LOWEST BID PRICE;**

23 **(II) HAS THE LOWEST EVALUATED BID PRICE; OR**

24 **(III) FOR PROCUREMENTS SUBJECT TO § 11-202(3) OF THIS**
25 **ARTICLE, IS THE BID MOST FAVORABLE TO THE STATE; AND**

26 **(2) MEETS OR MAKES A GOOD FAITH EFFORT TO MEET ANY**
27 **APPLICABLE OVERALL PERCENTAGE GOAL ESTABLISHED UNDER THIS SUBTITLE.**

28 **(B) FOR PROCUREMENTS CONDUCTED BY COMPETITIVE SEALED**
29 **PROPOSALS, A UNIT SHALL AWARD THE CONTRACT TO THE RESPONSIBLE OFFEROR:**

30 **(1) PROPOSING THE MOST ADVANTAGEOUS OFFER; AND**

1 **(2) THAT MEETS OR MAKES A GOOD FAITH EFFORT TO MEET ANY**
2 **APPLICABLE OVERALL PERCENTAGE GOAL ESTABLISHED UNDER THIS SUBTITLE.**

3 **14-804.**

4 **THE GOVERNOR'S OFFICE OF SMALL, MINORITY, AND WOMEN BUSINESS**
5 **AFFAIRS SHALL:**

6 **(1) ADOPT REGULATIONS TO IMPLEMENT THIS SUBTITLE;**

7 **(2) ESTABLISH PROCEDURES FOR TRACKING AND REPORTING**
8 **PARTICIPATION OF HISTORICALLY UNDERUTILIZED BUSINESS ZONE BUSINESSES**
9 **UNDER THIS SUBTITLE; AND**

10 **(3) ON OR BEFORE DECEMBER 1 EACH YEAR, REPORT TO THE**
11 **LEGISLATIVE POLICY COMMITTEE ON:**

12 **(I) THE NUMBER AND DOLLAR VALUE OF CONTRACTS**
13 **AWARDED TO HISTORICALLY UNDERUTILIZED BUSINESS ZONE BUSINESSES UNDER**
14 **THIS SUBTITLE, INCLUDING THE TOTAL DOLLAR VALUE OF PAYMENTS MADE TO**
15 **HISTORICALLY UNDERUTILIZED BUSINESS ZONE BUSINESSES UNDER EXISTING**
16 **CONTRACTS; AND**

17 **(II) AN EVALUATION OF THE EFFECTIVENESS OF**
18 **PARTICIPATION AMONG HISTORICALLY UNDERUTILIZED BUSINESS ZONE**
19 **BUSINESSES UNDER THIS SUBTITLE.**

20 **14-805.**

21 **(A) A PERSON MAY NOT:**

22 **(1) KNOWINGLY AND WITH INTENT TO DEFRAUD, FRAUDULENTLY**
23 **OBTAIN OR ATTEMPT TO OBTAIN, OR AID ANOTHER PERSON IN FRAUDULENTLY**
24 **OBTAINING OR ATTEMPTING TO OBTAIN, PUBLIC MONEY, PROCUREMENT**
25 **CONTRACTS, OR FUNDS EXPENDED UNDER A PROCUREMENT CONTRACT TO WHICH**
26 **THE PERSON IS NOT ENTITLED UNDER THIS ARTICLE;**

27 **(2) KNOWINGLY AND WITH INTENT TO DEFRAUD, FRAUDULENTLY**
28 **REPRESENT PARTICIPATION OF A HISTORICALLY UNDERUTILIZED BUSINESS ZONE**
29 **BUSINESS IN ORDER TO OBTAIN OR RETAIN A BID PREFERENCE OR A PROCUREMENT**
30 **CONTRACT;**

1 **(3) WILLFULLY AND KNOWINGLY MAKE OR SUBSCRIBE TO ANY**
2 **STATEMENT, DECLARATION, OR OTHER DOCUMENT THAT IS FRAUDULENT OR FALSE**
3 **AS TO ANY MATERIAL MATTER, WHETHER OR NOT THAT FALSITY OR FRAUD IS**
4 **COMMITTED WITH THE KNOWLEDGE OR CONSENT OF THE PERSON AUTHORIZED OR**
5 **REQUIRED TO PRESENT THE DECLARATION, STATEMENT, OR DOCUMENT;**

6 **(4) WILLFULLY AND KNOWINGLY AID, ASSIST IN, PROCURE, COUNSEL,**
7 **OR ADVISE THE PREPARATION OR PRESENTATION OF A DECLARATION, STATEMENT,**
8 **OR OTHER DOCUMENT THAT IS FRAUDULENT OR FALSE AS TO ANY MATERIAL**
9 **MATTER, REGARDLESS OF WHETHER THAT FALSITY OR FRAUD IS COMMITTED WITH**
10 **THE KNOWLEDGE OR CONSENT OF THE PERSON AUTHORIZED OR REQUIRED TO**
11 **PRESENT THE DECLARATION, STATEMENT, OR DOCUMENT;**

12 **(5) WILLFULLY AND KNOWINGLY FAIL TO FILE ANY DECLARATION OR**
13 **NOTICE WITH THE UNIT THAT IS REQUIRED BY THIS SUBTITLE; OR**

14 **(6) ESTABLISH, KNOWINGLY AID IN THE ESTABLISHMENT OF, OR**
15 **EXERCISE CONTROL OVER A BUSINESS FOUND TO HAVE VIOLATED A PROVISION OF**
16 **ITEMS (1) THROUGH (5) OF THIS SUBSECTION.**

17 **(B) (1) A PERSON WHO VIOLATES ANY PROVISION OF SUBSECTION (A) OF**
18 **THIS SECTION SHALL BE GUILTY OF A MISDEMEANOR AND ON CONVICTION IS**
19 **SUBJECT TO A FINE NOT EXCEEDING \$1,000 OR IMPRISONMENT NOT EXCEEDING 6**
20 **MONTHS OR BOTH.**

21 **(2) IN ADDITION TO THE PENALTIES UNDER PARAGRAPH (1) OF THIS**
22 **SUBSECTION, A PERSON WHO VIOLATES ANY PROVISION OF SUBSECTION (A) OF THIS**
23 **SECTION SHALL BE:**

24 **(I) FOR THE FIRST OFFENSE, LIABLE FOR A CIVIL PENALTY OF**
25 **NOT LESS THAN \$10,000 AND NOT EXCEEDING \$30,000; AND**

26 **(II) FOR A SUBSEQUENT OFFENSE, LIABLE FOR A CIVIL PENALTY**
27 **OF NOT LESS THAN \$30,000 AND NOT EXCEEDING \$50,000.**

28 **(3) A PERSON WHO VIOLATES ANY PROVISION OF SUBSECTION (A) OF**
29 **THIS SECTION SHALL PAY ALL COSTS AND ATTORNEY'S FEES INCURRED BY THE**
30 **PLAINTIFF IN A CIVIL ACTION BROUGHT UNDER THIS SUBTITLE.**

31 **(C) THE BOARD SHALL PROHIBIT A BUSINESS OR PERSON WHO FAILS TO**
32 **SATISFY THE PENALTIES, COSTS, AND ATTORNEY'S FEES IMPOSED UNDER**
33 **SUBSECTION (B) OF THIS SECTION FROM FURTHER CONTRACTING WITH THE STATE**
34 **UNTIL THE PENALTIES ARE SATISFIED.**

1 **(D) (1) A UNIT SHALL REPORT ALL ALLEGED VIOLATIONS OF THIS**
2 **SECTION TO THE BOARD.**

3 **(2) THE BOARD SUBSEQUENTLY SHALL REPORT ALL ALLEGED**
4 **VIOLATIONS OF THIS SECTION TO THE OFFICE OF THE ATTORNEY GENERAL, WHICH**
5 **SHALL DETERMINE WHETHER TO BRING A CIVIL ACTION AGAINST A PERSON OR**
6 **BUSINESS FOR A VIOLATION OF THIS SECTION.**

7 **14-806.**

8 **IN ADDITION TO THE PENALTIES UNDER § 14-805(B) OF THIS SUBTITLE, A**
9 **PERSON THAT WILLFULLY MISREPRESENTS A BUSINESS AS A HISTORICALLY**
10 **UNDERUTILIZED BUSINESS ZONE BUSINESS FOR PURPOSES OF OBTAINING OR**
11 **RETAINING A CONTRACT OR SUBCONTRACT MAY BE SUBJECT TO:**

12 **(1) SUSPENSION OR DEBARMENT UNDER TITLE 16 OF THIS ARTICLE;**
13 **OR**

14 **(2) CIVIL PENALTIES UNDER THE MARYLAND FALSE CLAIMS ACT**
15 **UNDER TITLE 8 OF THE GENERAL PROVISIONS ARTICLE.**

16 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect**
17 **October 1, 2023.**
