A BILL ENTITLED

1 AN ACT concerning

2 Public Safety – Gun Violence Victim Relocation Program – Establishment

3 FOR the purpose of establishing the Gun Violence Victim Relocation Program within the 4 Victim Services Unit of the Governor's Office of Crime Prevention, Youth, and Victim $\mathbf{5}$ Services to provide certain victims of gun violence certain services and assistance 6 related to relocating for the safety of the victim or the victim's family; establishing 7 the Gun Violence Victim Relocation Program Fund as a special, nonlapsing fund; 8 requiring interest earnings of the Fund to be credited to the Fund; requiring the 9 Victim Services Unit to establish a certain oversight commission; and generally 10 relating to the Gun Violence Victim Relocation Program.

9 (A) THERE IS A GUN VIOLENCE VICTIM RELOCATION PROGRAM WITHIN 10 THE VICTIM SERVICES UNIT.

11 **(B)** THE PURPOSE OF THE PROGRAM IS TO ASSIST IN THE RELOCATION OF 12 VICTIMS OF GUN VIOLENCE IN THE STATE TO ENSURE THE SAFETY AND WELL–BEING 13 OF THE VICTIM AND THE VICTIM'S FAMILY.

14 (C) THIS SUBTITLE SHALL BE LIBERALLY CONSTRUED AND APPLIED TO 15 PROMOTE ITS UNDERLYING PURPOSE.

17 (A) (1) AN INDIVIDUAL MAY REQUEST PARTICIPATION IN THE PROGRAM 18 THROUGH THE VICTIM SERVICES UNIT.

19 (2) AN INDIVIDUAL IS ELIGIBLE FOR ASSISTANCE THROUGH THE 20 PROGRAM IF:

21 (I) THE INDIVIDUAL IS A VICTIM OF GUN VIOLENCE IN THE 22 STATE;

23(II)1.THE INDIVIDUAL EXPERIENCED THE VIOLENCE24WITHIN CLOSE PROXIMITY TO THE INDIVIDUAL'S HOME; OR

25 **2.** THE INDIVIDUAL LIVES IN CLOSE PROXIMITY TO A 26 PERSON WHO IS SUSPECTED TO HAVE CAUSED THE VIOLENCE; AND

27 (III) THE INDIVIDUAL DEMONSTRATES A NEED TO BE 28 RELOCATED FOR THE SAFETY OF THE INDIVIDUAL OR THE INDIVIDUAL'S FAMILY.

6 (B) THE VICTIM SERVICES UNIT SHALL KEEP THE PERSONAL 7 INFORMATION OF AN INDIVIDUAL WHO APPLIES FOR THE PROGRAM UNDER 8 SUBSECTION (A) OF THIS SECTION CONFIDENTIAL, INCLUDING THE ADDRESS AND 9 ANY OTHER IDENTIFYING INFORMATION OF THE INDIVIDUAL.

11 (A) THE VICTIM SERVICES UNIT SHALL ASSIST AN ELIGIBLE VICTIM 12 ACCEPTED INTO THE PROGRAM BY:

13(1) RELOCATING THE VICTIM AND THE VICTIM'S FAMILY TO A SAFE14LOCATION;

15 (2) PROVIDING THE VICTIM WITH FINANCIAL ASSISTANCE FOR 16 MOVING EXPENSES, SECURITY DEPOSIT, AND RENT; AND

17(3) PROVIDING OTHER SUPPORT SERVICES, INCLUDING18COUNSELING, LEGAL ASSISTANCE, JOB TRAINING, AND RESOURCES AND SERVICES19FOR INDIVIDUALS WITH DISABILITIES.

(1) COLLABORATE WITH OTHER STATE AND LOCAL AGENCIES,

 PROVIDE COMPREHENSIVE SERVICES TO VICTIMS UNDER THE PROGRAM;

 25 PUBLIC ABOUT THE PROGRAM AND TO ENCOURAGE VICTIMS OF GUN VIOLENCE TO

(3) WORK TO ENSURE THAT VICTIMS UNDER THE PROGRAM WHO ARE
RENTERS ARE PROTECTED FROM EVICTION OR FROM BEING DENIED RENTAL
HOUSING BASED ON THE VICTIM'S STATUS IN THE PROGRAM.

6 (A) THERE IS A GUN VIOLENCE VICTIM RELOCATION PROGRAM FUND.

7 (B) THE PURPOSE OF THE FUND IS TO CARRY OUT THE PROVISIONS OF THIS 8 SUBTITLE.

9 (C) THE VICTIM SERVICES UNIT SHALL ADMINISTER THE FUND.

10 (D) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT 11 SUBJECT TO § 7–302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

7 (A) THE VICTIM SERVICES UNIT SHALL ESTABLISH AN OVERSIGHT 8 COMMISSION TO ENSURE THAT THE PROGRAM IS BEING ADMINISTERED PROPERLY 9 AND THAT THE FUND IS BEING USED APPROPRIATELY.

10 (B) ON OR BEFORE DECEMBER 1 EACH YEAR, BEGINNING IN 2025, THE 11 VICTIM SERVICES UNIT SHALL SUBMIT A REPORT ON THE STATUS OF THE PROGRAM 12 TO THE GOVERNOR AND, IN ACCORDANCE WITH § 2–1257 OF THE STATE 13 GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY THAT INCLUDES:

- 14 (1) THE NUMBER OF INDIVIDUALS ACCEPTED INTO THE PROGRAM;
- 15 (2) THE NUMBER OF INDIVIDUALS WHO APPLIED FOR THE PROGRAM;
- 16(3)THE TYPES OF SERVICES PROVIDED TO THE VICTIMS UNDER THE17PROGRAM;

18 (4) AN OUTLINE OF HOW THE FUND IS USED TO SUPPORT THE 19 PROGRAM;

20 (5) AN EVALUATION OF THE PROGRAM; AND

(a) (2) (i) Notwithstanding any other provision of law, and unless inconsistent with a federal law, grant agreement, or other federal requirement or with the terms of a gift or settlement agreement, net interest on all State money allocated by the State Treasurer under this section to special funds or accounts, and otherwise entitled to receive interest earnings, as accounted for by the Comptroller, shall accrue to the General
