 daily compensation for election judges; requiring the State Board of Elections to
 reimburse each local board a certain amount of certain compensation that is paid to
 each returning election judge and to develop and implement a certain market
 campaign; and generally relating to compensation for election judges.

- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
