10. Description and Purpose of Organization (Limit length to visible area)

CaringMatters is a 33-year-old organization whose mission is to provide social supports and community education so that no one dies or grieves alone. Services are free and delivered by trained volunteers. Volunteer Helping Hands visits seriously ill seniors for companionship, practical help or transportation. Family Caregiver Support Groups reduce isolation. A weekend retreat helps long-time family caregivers identify a "new" life after that person dies. In school-based Good Grief Clubs, Camp Erin, and Adult Peer Support Groups, grieving participants better understand their grief and learn coping skills. Parenting While Grieving helps adult caregivers better support children whose parent has died. Family Nights increase members communication about their shared loss. Regular webinars educate the public and helping professionals about end-of-life, death and grief.

11. Description and Purpose of Project (Limit length to visible area)

CaringMatters offices are in a building called "The Cottage", with a homelike decor and atmosphere, which creates a warm and comfortable setting for grief support programs as well as volunteer training and meetings, and educational activities. The Cottage is owned by the City of Gaithersburg and is being leased to CaringMatters for a very nominal fee. CaringMatters is responsible for maintenance of the grounds. The Cottage grounds include a beautiful stone patio and walkway that is currently in disrepair and not safe for use. Over the years, this patio has been the setting for bereavement support groups, family programs, educational and volunteer events, and more. Now more than ever, due to the pandemic, there is an increased need and demand for our services. Having an outdoor area that is comfortable, attractive, well lit, and ADA accessible will allow us to expand programs and add the positive influence of nature to our work.
