10. Description and Purpose of Organization (Limit length to visible area)

GCLH provides personalized psychiatric rehabilitation/behavioral health services to individuals in our community, recovering from severe and persistent mental illness. We aim to provide services in a thoughtful, compassionate, and empowering manner by promoting community integration, the cultivation of available supports and resources, advocating for clients personal growth, and engaging in ethical practices. Safe Harbor offers intensive mental health and support services to adults with mental illness who are experiencing, or are at risk of, a psychiatric crisis which would impair their ability to function in the community. RCS is designed to prevent a psychiatric inpatient admission, provide an alternative to psychiatric inpatient admission, shorten the length of an inpatient stay, and reduce the pressure on hospital emergency departments and law enforcement.

11. Description and Purpose of Project (Limit length to visible area)

SH has been closed due to structural damage resulting from poor construction. Water was able to infiltrate the structure due to poor grading, construction work which was not up to code, and poor weatherization. Load-bearing studs, flooring, appliances, and insulation were all damaged. The remedy, as identified by local contractors, is to replace the damaged structural components, buy new appliances and furniture, deep clean the facility to eliminate mold spores, weatherize the building properly, and excavate around the sides of the structure to prevent future water intrusion. Although the cause of the damage and the remedy for it have been identified, the costs exceed what was anticipated for normal building upkeep. Closing the facility temporarily has deprived the agency of the needed revenue to fund the required repairs. This request is to make the repairs described above and reopen the facility. As this is the only facility of its kind for Garrett County.

28. Comments

Safe Harbor RCS has been Garrett Countys only mental health focused residential crisis facility since it was opened in 1998. During that time, the four RCS beds we operated and maintained served our community well by providing a safe, stable environment for individuals in a state of mental health crisis. It has provided our local emergency department at Garrett Regional Medical Center with an alternative to an inpatient hospital stay or to discharging someone to their home. Although it is not principally a homeless shelter, Safe Harbor has also provided an alternative to living on the streets for individuals recovering from severe mental illness. Finally, it has prevented many crises from escalating to fatal proportions.

We believe in the usefulness of this program because we have seen the results with our own eyes. We assisted 78, 91, and 67 people through RCS in FY 2019, 2020, and 2021, respectively. We got to know each of these 236 total individuals during their stay at our program. We were able to watch many of them work through their recovery plan and find a way forward. The support staff in RCS have been able to connect our clients with public benefits, support programs, mental health providers, and housing resources, all of which helps reduce the likelihood that a crisis will happen again in the future.

Our stakeholders in the community have been asking our administrative staff about the status of Safe Harbor since it was closed early on in FY 2023. Agencies like Community Action, the Garrett County Behavioral Health Clinic, and the Department of Social Services all seem eager for the program to resume. We have been looking forward to the day when we can finally reopen and resume our important work. It has been one of our agencys top priorities this fiscal year. We hope that you will lend your support to this project by helping to fund the repair costs so we can get back to providing Safe Harbor for all who require it.
