Iglesia de Dios Hispana de Owings Mills is a non-profit religious organization founded in 2018 to bring God's word and resources to the Latino community in Owings Mills. Our church is located on a main road, we want to make sure that our parking lot is not used for unauthorized parking or a place where illicit activity will take place during out of office hours. Furthermore, the majority of members have families. Before and after service, children are coming in and out of the church, having a fence will prevent a child from going out to the main road. We also open our space to be used to host community events throughout the year. Having a fence will give parents piece of mind and encourage more attendance thus children will be able to run freely and enjoy. Although our church membership is increasing, we don't have the monetary resources to afford this project. This funding will allow us to protect our children and prevent unauthorized access.
