10. Description and Purpose of Organization (Limit length to visible area)

The mission of The Arc NCR is to empower people with differing abilities (intellectual and/or developmental disabilities) to live, work and thrive in the community. Along with the vision of a world where people with differing abilities lead personally valued lives, The Arc NCR serves the community and its residents with the core values of Respect, Self Determination, Responsiveness, Inclusion and Community Building. Our organization was established in 1953 by a group of parents seeking educational and vocational opportunities for their children with intellectual and developmental disabilities. The organization has evolved from focusing on educational opportunities to focusing on people living independently in a home of their own, employment opportunities, and community engagement activities to further social skills.

The Arc NCR will renovate four of its residential homes. Each home has adult residents that are either aging or medically fragile and have an intellectual and/or developmental disability. The agency needs to renovate and modernize its homes in order for people to age in place. Residents can live in the home for as long as they wish, when they choose to move out, their spot will be open to the public for those who wish to apply and qualify for services. Below are details of the project: Tollgate Location: Houses 5 People - Renovate bathroom to make it handicap accessible. Hemlock Location: Houses 4 People - Renovate bathroom to make it handicap accessible. Clayton Location: Houses 4 People - Home built in the 1960's. General updates/renovations needed to modernize home and keep in good condition. Hampton Hall Location: Houses 3 people. Home built in the 1980's. General updates/renovations needed to modernize home and keep in good conditions needed to modernize home and keep in good condition.
