Senate Bill 457

(Senator Bailey)

Budget and Taxation

Appropriations

St. Mary's County - Public Facilities Bond

This bill authorizes the St. Mary’s County Commissioners to issue up to \$56.0 million in general obligation bonds for the acquisition, construction, improvement, or renovation of public buildings, facilities, and public works projects. The date of maturity of the bonds cannot exceed 30 years. **The bill takes effect June 1, 2023.**

Fiscal Summary

State Effect: None.

Local Effect: St. Mary’s County receives up to \$56.0 million in bond proceeds. County debt service expenditures increase by an estimated \$3.8 million annually over a 20-year period.

Small Business Effect: None.

Analysis

Current Law: Commission counties do not have the legislative power to create debt; General Assembly authorization is required before any bonds can be sold. St. Mary’s County is one of six counties that still operates under the commission form of government.

Local Fiscal Effect: Since 2008, St. Mary’s County has received authorization by the General Assembly to issue up to \$208.9 million in general obligation bonds for public facilities, as shown in **Exhibit 1**.

St. Mary's County revenues increase by up to \$56.0 million from bond proceeds. Annual debt service costs for the bonds total approximately \$3.8 million. This estimate is based on a 3.37% interest rate and a 20-year term of maturity. To the extent that the bond issuance, interest rate, or term of maturity deviate from this assumption, expenditures would adjust accordingly.

At the end of fiscal 2021, St. Mary's County had approximately \$229.0 million in total outstanding debt, which represents approximately 1.7% of the county's assessable base and \$2,010 on a per capita basis. The county currently has an AA+ rating from Standard & Poor's, an Aa1 credit rating from Moody's Investors Service, and an AA+ rating from Fitch Ratings.
