FOR the purpose of establishing the Maryland Aerospace and Technology Commission in the Department of Commerce to promote innovation in the fields of space exploration and commercial aerospace opportunities; ~~establishing the Maryland Aerospace and Technology Fund as a special, nonlapsing fund; requiring interest earnings from the Fund to be credited to the Fund;~~ and generally relating to the Maryland Aerospace and Technology Commission.
