On page 4, in line 1, strike "(2)" and substitute "(4)"; and in line 5, strike "a public welfare" and substitute "an"; and strike lines 7 and 8 in their entirety and substitute:

"SECTION 3. AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three-fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted."
