On page 8, in line 9, strike "BRONCHODILATOR" and substitute "STOCK BRONCHODILATOR IN ACCORDANCE WITH THIS SECTION"; in line 30, strike "OTHER" and substitute "DESIGNATED"; in line 33, strike "HAVE ASTHMA, IS" and substitute "BE OR PERCEIVED TO BE"; and in the same line, strike "SYMPTOMS," and substitute "SYMPTOMS".

On page 9, in line 6, after "OTHER" insert "<u>DESIGNATED</u>"; in line 18, strike "VOLUNTEER" and substitute "<u>SCHOOL PERSONNEL</u>"; after line 18, insert:
