AMENDMENTS TO SENATE BILL 541
(Third Reading File Bill)

AMENDMENT NO. 1

On page 10, in line 9, after “**ABORTION**” insert a comma.

On page 17, in line 10, after “**FROM**” insert a comma.

AMENDMENT NO. 2

On page 3, in line 22, strike “**ARE**” and substitute “**CAN BE**”.

On page 13, strike beginning with the colon in line 5 down through “**(I)**” in line 11 and substitute “**CONDUCTS BUSINESS IN THE STATE OR PROVIDES PRODUCTS OR SERVICES THAT ARE TARGETED TO RESIDENTS OF THE STATE, AND THAT DURING THE PRECEDING CALENDAR YEAR DID ANY OF THE FOLLOWING:**

(1)”;

in line 15, strike “**(II)**” and substitute “**(2)**”; and in line 21, strike “**OR**”.

On page 16, in line 11, strike “**TO THE EXTENT IT IS**”; strike beginning with “**FOR,**” in line 11 down through “**BY**” in line 12 and substitute “**BY OR ON BEHALF OF**”.

AMENDMENT NO. 3

On page 22, strike beginning with “**WITHOUT**” in line 8 down through “**CONSENT**” in line 9.

On page 23, in line 27, after “PROGRAM” insert “, PROVIDED THAT THE SELLING OF PERSONAL DATA IS NOT A CONDITION OF PARTICIPATION IN THE PROGRAM”.

On page 24, in line 13, after “(E)” insert “(1)”; and after line 19, insert:

“(2) THE DISCLOSURE REQUIRED UNDER PARAGRAPH (1) OF THIS SUBSECTION SHALL BE PROMINENTLY DISPLAYED, AND USE CLEAR, EASY TO UNDERSTAND, AND UNAMBIGUOUS LANGUAGE, TO STATE WHETHER THE CONSUMER’S INFORMATION WILL BE SOLD OR SHARED WITH A THIRD PARTY.”

AMENDMENT NO. 4

On page 33, strike beginning with the first “OR” in line 8 down through “BODY” in line 9 and substitute “, CRIMINAL, OR REGULATORY INQUIRY, INVESTIGATION, SUBPOENA, OR SUMMONS BY A FEDERAL, STATE, LOCAL, OR OTHER GOVERNMENTAL AUTHORITY”.

AMENDMENT NO. 5

On page 35, in line 1, strike the comma and substitute “:

(I)”;

in line 4, after “SUBTITLE” insert “; AND

“(II) THE DISCLOSING CONTROLLER WAS, AND REMAINED, IN COMPLIANCE WITH ITS OBLIGATIONS AS THE DISCLOSER OF THE PERSONAL DATA”.

On page 37, in line 18, after “SECTION 3.” insert “AND BE IT FURTHER ENACTED, That, if any provision of this Act or the application thereof to any person or circumstance is held invalid for any reason in a court of competent jurisdiction, the invalidity does not affect other provisions or any other application of this Act that can be given effect without the invalid provision or application, and for this purpose the provisions of this Act are declared severable.
