AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**Delegates Love, Baker, and Jacobs**” and substitute “**Delegate Love**”; in line 6, after “system” insert “without a warrant, subpoena, or court order”; and in line 26, after “21-810(b)(1),” insert “21-1134(c)(1)”.

On page 2, in line 3, after “21-810(i),” insert “21-1134(l)”.

in line 18, after “DATA” insert “**WITHOUT A WARRANT, SUBPOENA, OR COURT  
ORDER**”; in the same line, after “THE” insert “**ACCESS OR**”; and in line 20, after “(2)”  
insert “**AN AGENCY MAY ACCESS AND USE A RECORDED IMAGE AND ASSOCIATED  
DATA WITHOUT A WARRANT, SUBPOENA, OR COURT ORDER IN EXIGENT  
CIRCUMSTANCES.**”

**(3) AN EMPLOYEE OR A CONTRACTOR OF AN AGENCY MAY ACCESS  
AND USE A RECORDED IMAGE AND ASSOCIATED DATA:**

**(I) TO AUDIT OR EVALUATE THE ACCURACY OF THE  
AUTOMATED ENFORCEMENT SYSTEM; AND**

**(II) IN A MANNER CONSISTENT WITH SUBSECTION (D) OF  
THIS SECTION.**

(c) (1) Baltimore City may use a bus lane monitoring system that meets the requirements of this subsection to record the images of motor vehicles traveling in a bus lane.

(1) (1) In consultation with the Baltimore City Police Department, the Chief Judge of the District Court shall adopt procedures for the issuance of citations, trials for violations, and the collection of civil penalties imposed under this section.

(2) THE STANDARDS AND REQUIREMENTS FOR THE USE, PROCESSING, AND DISPOSAL OF RECORDED IMAGES AND ASSOCIATED DATA ESTABLISHED UNDER § 12-113.1 OF THIS ARTICLE APPLY TO CITATIONS ISSUED UNDER THIS SECTION.”.
