AMENDMENTS TO HOUSE BILL 243
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 3, after “certain” insert “owner-occupied”; in line 7, after “for” insert “owner-occupied”; and strike beginning with “requiring” in line 20 down through “plan;” in line 23.

On page 2, in line 2, strike “14-811(a), (b),” and substitute “14-811(b)”; in line 3, strike the third comma and substitute “and”; and in the same line, strike “and (d),”.

AMENDMENT NO. 2

On page 2, strike in their entirety lines 16 through 18, inclusive; in line 19, after “any” insert “NON-OWNER-OCCUPIED”; in line 24, after “sale” insert “OWNER-OCCUPIED”; in line 28, after “**THE**” insert “MAYOR AND CITY COUNCIL OF BALTIMORE CITY OR THE”; in line 30, strike the bracket; and in line 31, strike the bracket and substitute “OR THE”.

On page 4, in line 21, strike the first bracket; in the same line, strike the second bracket and substitute “OR THE”; in line 25, strike “**SUBSECTIONS**” and substitute “SUBSECTION”; and in the same line, strike “**AND (D)**”.

On page 5, in line 7, in each instance, strike the bracket; and in the same line, strike “**10%**”.

On page 6, strike beginning with “**THE**” in line 3 down through “**(D)**” in line 5; in line 6, strike “**6%**” and substitute “10%”; in line 7, strike “**(E)**” and substitute “(D)”; in line 24, strike the first bracket; and in the same line, strike the second bracket and substitute “OF BALTIMORE CITY OR THE”.

On page 7, in line 23, after the second “the” insert “MAYOR AND CITY COUNCIL OF BALTIMORE CITY OR THE”; in line 33, strike the bracket; and in line 34, strike the bracket and substitute “OR”.

On page 8, in line 1, strike the first bracket; and in the same line, strike the second bracket and substitute “OR THE”.

On page 10, strike in their entirety lines 5 through 9, inclusive; in line 13, strike the first bracket; in the same line, strike the second bracket and substitute “OF BALTIMORE CITY OR THE”; in line 14, strike the first bracket; in the same line, strike the second bracket and substitute a comma; in line 15, after “COUNTY” insert a comma; and in line 29, after “THE” insert “MAYOR AND CITY COUNCIL OF BALTIMORE CITY OR THE”.

On page 11, in line 1, strike “a” and substitute “AN OWNER–OCCUPIED”; in line 6, strike the first bracket; in the same line, strike the second bracket and substitute “OR THE”; in line 8, after “than” insert “OWNER–OCCUPIED”; in line 11, strike the first bracket; in the same line, strike the second bracket and substitute a comma; in line 12, after “COUNTY” insert a comma; and in the same line, after “OR” insert “A”.
