AMENDMENTS TO HOUSE BILL 763

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, after “Attar,” insert “**Cardin,**”; in the same line, strike “**and Rosenberg**” and substitute “**Rosenberg, Simmons, Tomlinson, Arikan, Conaway, and Kaufman**”; strike beginning with “**Membership**” in line 2 down through “**Alterations**” in line 3 and substitute “**Membership and Sunset**”; strike beginning with “removing” in line 4 down through “from” in line 5 and substitute “**altering the membership of**”; and strike beginning with “adding” in line 6 down through “Commission;” in line 7 and substitute “**terminating the Commission after a certain date;**”.

AMENDMENT NO. 2

On page 1, in line 22, strike “one representative of the Anti-Defamation League” and substitute “**15 INDIVIDUALS WHO REPRESENT OR ADVOCATE ON BEHALF OF INDIVIDUALS WHO ARE MEMBERS OF A PROTECTED CLASS UNDER THE STATE HATE CRIME LAWS AS SET FORTH IN TITLE 10, SUBTITLE 3 OF THE CRIMINAL LAW ARTICLE**”.

On page 2, strike beginning with “one” in line 1 down through “(10)” in line 11; in lines 13, 14, 15, 16, 17, 18, and 24, respectively, strike “(11)”, “(12)”, “(13)”, “(14)”, “(15)”, “(16)”, and “(21)”, respectively, and substitute “**(3)**”, “**(4)**”, “**(5)**”, “**(6)**”, “**(7)**”, “**(8)**”, and “**(10)**”, respectively; and strike lines 19 through 23 in their entirety and substitute:

“**(9) ONE REPRESENTATIVE OF THE OFFICE OF THE PUBLIC DEFENDER; AND**”.

On page 3, in line 1, after “(2)” insert “**(I)**”; in the same line, strike “The” and substitute “**EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS PARAGRAPH, THE**”; and after line 2, insert:

“(II) THE TERMS OF THE MEMBERS APPOINTED UNDER SUBSECTION (B)(1) AND (9) OF THIS SECTION ARE STAGGERED AS REQUIRED BY THE TERMS PROVIDED FOR MEMBERS OF THE COMMISSION ON OCTOBER 1, 2024.”.

On page 4, after line 3, insert:

“(J) THIS SECTION, AND ALL REGULATIONS AND POLICIES ADOPTED UNDER THIS SECTION, SHALL TERMINATE AND BE OF NO EFFECT AFTER JUNE 30, 2027.”;

in line 6, strike “6–802(b)(6)” and substitute “6–802(b)(1) and (9)”; and strike lines 8 and 9 in their entirety and substitute:

- “(1) five members in 2025;
- “(2) five members in 2026; and
- “(3) six members in 2027.”
