#### AMENDMENT NO. 1

On page 1, strike beginning with "repealing" in line 5 down through "states;" in line 9 and substitute "authorizing a local school system to establish a comprehensive induction program to aid in meeting a certain requirement for initial teacher certification; altering the qualification requirements for a teacher who holds a professional license or certificate from another state;".

### AMENDMENT NO. 2

On page 2, strike beginning with "at" in line 23 down through "Massachusetts" in line 24 and substitute "<u>SUFFICIENTLY RIGOROUS</u>".

On page 3, strike beginning with "at" in line 3 down through "Massachusetts" in line 4 and substitute "<u>RIGOROUS</u>, <u>AS DEFINED BY THE DEPARTMENT</u>"; in line 26, after the semicolon insert "<u>OR</u>"; in line 27, after "2." insert "<u>SUBJECT TO PARAGRAPH</u> (4) OF THIS SUBSECTION, COMPLETE A RIGOROUS LOCAL SCHOOL SYSTEM TEACHER INDUCTION PROGRAM THAT LASTS FOR THE LESSER OF:

in the same line, after "BASIC" insert "LITERACY"; in the same line, after "ASSESSMENT" insert "APPROVED BY THE DEPARTMENT UNDER § 6–125 OF THIS SUBTITLE"; in lines 28 and 32, strike "3." and "4.", respectively, and substitute "2." and "3.", respectively; in line 32, strike "SATISFACTORY"; and in line 33, strike "SATISFACTORY" and substitute "HAVING RECEIVED EFFECTIVE".

On page 4, strike beginning with "FROM" in line 1 down through "CERTIFICATE" in line 5 and substitute "FOR 3 YEARS"; in line 5, strike "AND"; in lines 6, 7, 15, 16, 18, and 19, in each instance, strike the bracket; in lines 6 and 8, strike "(ii)" and "(iii)", respectively, and substitute "(IV)" and "(V)", respectively; after line 13, insert:

- "(4) (I) IN ORDER TO SATISFY THE REQUIREMENTS OF PARAGRAPH (2)(II)2 OF THIS SUBSECTION, A CANDIDATE FOR AN INITIAL TEACHER CERTIFICATE SHALL SUBMIT DOCUMENTATION TO THE DEPARTMENT THAT THE CANDIDATE HAS COMPLETED A RIGOROUS COMPREHENSIVE INDUCTION PROGRAM, ESTABLISHED IN ACCORDANCE WITH § 6–117 OF THIS SUBTITLE, THAT MEETS THE REQUIREMENTS OF THIS PARAGRAPH.
- (II) THE COMPREHENSIVE INDUCTION PROGRAM SHALL BE DEVELOPED BY A LOCAL SCHOOL SYSTEM, EITHER INDEPENDENTLY OR COLLABORATIVELY WITH OTHER LOCAL SCHOOL SYSTEMS.
- (III) BEFORE ESTABLISHING A COMPREHENSIVE INDUCTION PROGRAM, ONE OR MORE LOCAL SCHOOL SYSTEMS SHALL SUBMIT A PLAN FOR THE PROGRAM TO THE DEPARTMENT AND THE ACCOUNTABILITY AND IMPLEMENTATION BOARD.
- (IV) THE COMPREHENSIVE INDUCTION PROGRAM SHALL INCLUDE A LOCALLY DEVELOPED PORTFOLIO COMPONENT THAT IS ALIGNED

WITH THE INTERSTATE TEACHER ASSESSMENT AND SUPPORT CONSORTIUM STANDARDS.

- (V) A TEACHER PREPARATION PROGRAM OR AN ALTERNATIVE TEACHER PREPARATION PROGRAM MAY USE THE LOCALLY DEVELOPED PORTFOLIO COMPONENT UNDER SUBPARAGRAPH (IV) OF THIS PARAGRAPH AS MEETING A PORTION OF THE COURSEWORK REQUIREMENTS OF THE PROGRAM.
- (VI) A CANDIDATE WHO SATISFACTORILY COMPLETES A
  COMPREHENSIVE INDUCTION PROGRAM ESTABLISHED IN ACCORDANCE WITH
  THIS PARAGRAPH MAY NOT BE REQUIRED TO PASS A NATIONALLY RECOGNIZED,
  PORTFOLIO-BASED ASSESSMENT OF TEACHING ABILITY.";

strike beginning with "MEET" in line 19 down through "or" in line 20 and substitute a semicolon; and in line 22, after "Standards" insert "; OR

(3) COMPLETE A COMPREHENSIVE INDUCTION PROGRAM IN ACCORDANCE WITH SUBSECTION (A)(4) OF THIS SECTION".

On page 5, in line 13, strike the brackets; in the same line, strike "SHALL PURSUE AND"; and strike beginning with "THAT" in line 14 down through "TITLE" in line 16.
