AMENDMENTS TO SENATE BILL 155
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “**Authorization**” and substitute “**Pilot Program**”; in line 3, strike “authorizing” and substitute “**establishing a pilot program to authorize**”; strike beginning with “Anne” in line 3 down through the first “County,” in line 4; and in line 4, strike the second comma.

AMENDMENT NO. 2

On page 4, strike beginning with the colon in line 27 down through “**A**” in line 28 and substitute “**A COUNTY**”; in lines 28 and 29, strike “**OF A LOCAL POLITICAL SUBDIVISION**”; and strike beginning with the semicolon in line 30 down through “**SECTION**” in line 34.

AMENDMENT NO. 3

On page 5, in line 14, after “**SUBTITLE**” insert “**BY AT LEAST 5 DECIBELS**”.

AMENDMENT NO. 4

On page 6, in line 13, after “**SUBTITLE**” insert “**BY AT LEAST 5 DECIBELS**”; strike beginning with “**NOISE**” in line 14 down through “**JURISDICTION**” in line 15 and substitute “**COUNTY MAY USE NOT MORE THAN THREE NOISE ABATEMENT MONITORING SYSTEMS**”; in line 15, strike “**ITS**” and substitute “**THE**”; in the same line, after “**THE**” insert “**COUNTY**”; and in line 16, strike “**OF THE LOCAL JURISDICTION**”.

On pages 6 and 7, strike beginning with “**BEFORE**” in line 18 on page 6 down through “**LOCATION**” in line 1 on page 7 and substitute “**A COUNTY MAY DEPLOY A NOISE ABATEMENT MONITORING SYSTEM AT MULTIPLE LOCATIONS AT DIFFERENT TIMES**”.

AMENDMENT NO. 5

On page 7 in lines 3 and 13, on page 8 in lines 22 and 25, on page 9 in line 21, on page 10 in line 1, and on page 14 in line 7, in each instance, strike “LOCAL JURISDICTION” and substitute “COUNTY”.

On page 7, in line 16, strike “LOCAL JURISDICTION’S” and substitute “COUNTY’S”.

On page 12, in line 13, strike “POLITICAL SUBDIVISION” and substitute “COUNTY”.

On page 13, in line 28, strike “LOCAL GOVERNMENT” and substitute “COUNTY”.

AMENDMENT NO. 6

On page 10, in line 9, after “(2)” insert “(I)”; in lines 11 and 12, strike “(I)” and “(II)”, respectively, and substitute “1.” and “2.”, respectively; in line 13, strike “\$70” and substitute “\$75”; after line 13, insert:

“(II) A COUNTY MAY NOT ISSUE A CITATION APPLICABLE TO A MOTOR VEHICLE DURING THE FIRST 30 DAYS AFTER A WARNING FOR A FIRST OFFENSE APPLICABLE TO THE MOTOR VEHICLE IS MAILED UNDER SUBPARAGRAPH (I)1 OF THIS PARAGRAPH.”;

in lines 21 and 22, strike “PER LOCAL JURISDICTION” and substitute “BY A COUNTY”; and in line 24, strike “THE PROVISIONS OF”.

AMENDMENT NO. 7

On page 14, in lines 10 and 11, strike “September 30, 2027, a local jurisdiction” and substitute “December 1, 2025, a county”; in line 12, after the first “the” insert

“Governor and in accordance with § 2–1257 of the State Government Article the”; strike beginning with the comma in line 12 down through “Act” in line 13 and substitute “on”:

(1) through October 1, 2025:

(i) the time period during which noise abatement monitoring systems were in use in the county; and

(ii) the number of warnings and citations issued as a result of violations recorded by noise abatement monitoring systems in the county over the reported time period, by location and date;

(2) (i) the costs associated with implementing and operating noise abatement monitoring systems; and

(ii) the revenue collected on a monthly basis as a result of violations recorded by noise abatement monitoring systems;

(3) appropriate locations for the deployment of noise abatement monitoring systems;

(4) the performance and reliability of noise abatement monitoring systems used by the county; and

(5) the effectiveness of noise abatement monitoring systems in reducing noise produced by motor vehicles in the county and in areas where the systems were implemented and used”;

in line 15, strike “October” and substitute “July”; in the same line, strike “4” and substitute “2”; in the same line, strike “September” and substitute “June”; and in line 16, strike “2028” and substitute “2026”.
