No amount of

these funds shall be used for projects that are inaccessible to the general public, require memberships, exclude the public because of higher user fees, or which include office, residential, or elaborate lodging facilities. To the greatest extent possible, these funds shall be encumbered for projects during State Fiscal 2022. The department shall administer funds in a similar manner as Program Open Space Local grants for ACQUISITION AND development projects with the exception that the matching requirement is waived. Funding shall be used to supplement the funds that would, in the absence of this funding, be made available from State and non-State sources for the provision of recreational amenities, and not to supplant such funds. NOTWITHSTANDING THAT A CERTAIN PORTION OF THIS AUTHORIZATION IS TO BE ADMINISTERED IN A SIMILAR MANNER TO PROGRAM OPEN SPACE LOCAL GRANTS, A PORTION OF THIS AUTHORIZATION MAY BE USED FOR ACQUISITION. Further provided that this authorization shall be allocated as follows:.....
