AMENDMENTS TO SENATE BILL 1006
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, after “**Hospitals**” insert “**Located in Baltimore City**”; in line 3, after “hospital” insert “**located in Baltimore City**”; in line 4, after “of” insert “**certain**”; in the same line, strike “a governmental unit” and substitute “**Baltimore City**”; in line 5, strike “the unit” and substitute “**Baltimore City**”; in the same line, strike “a hospital’s” and substitute “**the**”; and in line 6, after “policy” insert “**of a hospital located in Baltimore City**”.

AMENDMENT NO. 2

On page 2, in line 19, strike “**FOR HOSPITAL**” and substitute “**IF THE HOSPITAL IS LOCATED IN BALTIMORE CITY, THE**”; in the line 20, strike “**A GOVERNMENTAL UNIT**” and substitute “**BALTIMORE CITY**”; in the same line, after “**OR**” insert “**A**”; in line 25, strike “**THE UNIT OR**” and substitute “**BALTIMORE CITY OR THE**”; in line 27, strike “**THE UNIT**” and substitute “**BALTIMORE CITY**”; and in the same line, after the second “**OR**” insert “**THE**”.

On page 4, in line 1, strike “**REQUIRE**” and substitute “**IF THE HOSPITAL IS LOCATED IN BALTIMORE CITY, REQUIRE**”; and in line 4, strike “**PROHIBIT**” and substitute “**IF THE HOSPITAL IS LOCATED IN BALTIMORE CITY, PROHIBIT**”.

On page 5, in line 7, after the first “**HOSPITAL**” insert “**LOCATED IN BALTIMORE CITY**”; in the same line, after “**PATIENT**” insert “**WHO IS A RESIDENT OF BALTIMORE CITY**”; in line 8, strike “**A GOVERNMENTAL UNIT**” and substitute “**BALTIMORE CITY**”; in line 9, strike “**THE UNIT**” and substitute “**BALTIMORE CITY**”; in line 10, strike the second “**THE**”; in line 11, strike “**GOVERNMENTAL UNIT**” and substitute “**BALTIMORE**”.

CITY"; in the same line, after "OR" insert "THE"; and in lines 17 and 18, strike "THE GOVERNMENTAL UNIT" and substitute "BALTIMORE CITY".

On page 6, after line 31, insert:

"SECTION 2. AND BE IT FURTHER ENACTED, That it is the intent of the General Assembly that Baltimore City use federal American Rescue Plan Act funds to implement Section 1 of this Act."

On page 7, in line 1, strike "2." and substitute "3.".
