SYSTEM:

<u>1.</u> <u>THAT CONTAIN EVIDENCE OF A VIOLATION MAY BE</u> <u>RETAINED FOR UP TO 6 MONTHS OR 60 DAYS AFTER FINAL DISPOSITION OF THE</u> <u>CITATION, WHICHEVER IS LATER;</u>

2. <u>THAT DO NOT CONTAIN EVIDENCE OF A VIOLATION</u> SHALL BE DESTROYED WITHIN 15 DAYS AFTER THE RECORDED IMAGES WERE FIRST CAPTURED; AND

<u>3.</u> <u>MAY NOT BE USED FOR ANY PURPOSE OTHER THAN</u> <u>AS EVIDENCE OF A VIOLATION WITHOUT A WARRANT, SUBPOENA, OR COURT</u> <u>ORDER.</u>

(III) <u>A BUS LANE MONITORING SYSTEM MAY NOT USE</u> <u>BIOMETRIC IDENTIFICATION TECHNIQUES, INCLUDING FACIAL RECOGNITION</u> <u>TECHNOLOGY.</u>".

AMENDMENT NO. 5
