AMENDMENTS TO HOUSE BILL 127
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 5, strike “and health care providers”; in line 6, strike “prescribe or”; and in line 13, strike “13–5205” and substitute “13–5203”.

AMENDMENT NO. 2

On page 2, in line 16, after “**WITH**” insert “**THE MOST RECENT**”; strike in their entirety lines 21 through 24, inclusive; in lines 25 and 27, strike “**(G)**” and “**(H)**”, respectively, and substitute “**(F)**” and “**(G)**”, respectively; and in line 28, strike “**AND HEALTH CARE PROVIDERS**”.

On page 3, in line 6, after “**SUBTITLE;**” insert “**AND**”; strike beginning with “**AUTHORIZE**” in line 7 down through “**(3)**” in line 10; in line 12, strike “**NECESSARY**” and substitute “**:**”

(1) NECESSARY;

in line 13, after “**PROGRAM**” insert “**;****AND**”

(2) THAT ADDRESS THE NEEDS OF SPECIFIC POPULATIONS INCLUDING VICTIMS OF SEXUAL ASSAULT AND PEDIATRIC PATIENTS;

in line 16, after “**PROGRAM**” insert “**, UNLESS THE PATIENT QUALIFIES FOR NPEP THROUGH THE PROGRAM FOR PREVENTING HIV INFECTION FOR RAPE VICTIMS ESTABLISHED UNDER § 11–1008 OF THE CRIMINAL PROCEDURE ARTICLE**”; and in line 18, strike “**PRIVATE AND PUBLIC ENTITIES**” and substitute “**PHARMACISTS**”.

On page 4, in line 11, after “WITH” insert “THE MOST RECENT”; in the same line, strike “THE” and substitute “:

(I) THE;

in line 12, after “MEDICATIONS;” insert “AND

(II) IF APPLICABLE, EXPOSURE AS THE RESULT OF AN ALLEGED RAPE OR SEXUAL OFFENSE OR ALLEGED CHILD SEXUAL ABUSE;;

in line 15, after “WITH” insert “THE MOST RECENT”; in line 23, after “OF” insert “LOCAL”; and in line 24, after “CLINICS” insert “PROVIDED BY THE DEPARTMENT”.

On page 6, in line 22, strike “PRESCRIBING AND”.

AMENDMENT NO. 3

On page 5, strike in their entirety lines 1 through 14, inclusive.
