On page 2, in line 2, strike "(1)"; strike beginning with "THE" in line 2 down through "MEDIA" in line 10 and substitute "<u>, "SYNTHETIC MEDIA</u>"; in line 14, after "THAT" insert "<u>ATTEMPTS TO INFLUENCE THE CASTING OF A VOTE OR A DECISION</u> <u>TO VOTE BY</u>"; in lines 15 and 17, strike "(I)" and "(II)", respectively, and substitute "(1)" and "(2)", respectively; in line 15, strike "PURPORTS" and substitute "<u>PURPORTING</u>"; strike beginning with "INDIVIDUAL" in line 15 down through "CONDUCT;" in line 16 and substitute "<u>, CLEARLY IDENTIFIED CANDIDATE OR THE</u> <u>SPEECH OR CONDUCT OF THE CANDIDATE; OR</u>"; in line 17, strike "PRODUCES" and substitute "<u>PRODUCING</u>"; strike beginning with the semicolon in line 20 down through "MEDIA" in line 22; after line 22, insert:

"(B) (1) THIS SECTION APPLIES ONLY TO A CANDIDATE OR AN AGENT OF A CANDIDATE, A CAMPAIGN FINANCE ENTITY OR AN AGENT OF A CAMPAIGN

"(I) <u>A NEWS STORY, A COMMENTARY, OR AN EDITORIAL</u> <u>DISSEMINATED BY A BROADCASTING STATION, INCLUDING A CABLE TELEVISION</u> <u>OPERATOR, PROGRAMMER, OR PRODUCER, OR SATELLITE TELEVISION OR RADIO</u> <u>PROVIDER, WEBSITE, NEWSPAPER, MAGAZINE, OR OTHER PERIODICAL</u> <u>PUBLICATION, INCLUDING ANY INTERNET OR ELECTRONIC PUBLICATION, THAT</u> <u>IS NOT CONTROLLED BY A CANDIDATE OR POLITICAL PARTY; OR</u>".

On pages 2 and 3, strike in their entirety the lines beginning with line 24 on page 2 through line 13 on page 3, inclusive.

On page 3, in line 14, strike "(3)" and substitute "(II)"; in lines 15 and 18, strike "(1)" and "1.", respectively; in line 17, strike "WITHIN 90 DAYS BEFORE AN ELECTION"; in lines 18 and 23, strike "(I)" and "(II)", respectively, and substitute "(1)" and "(2)", respectively; in lines 18 and 19, strike "EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION,"; strike beginning with "OR" in line 20 down through "WEBSITE;" in line 22; and in line 23, strike "IN" and substitute "<u>IN</u>".

On pages 3 and 4, strike in their entirety the lines beginning with line 26 on page 3 through line 2 on page 4, inclusive.

On page 4, in lines 5, 14, and 27, in each instance, after "OCCUR" insert "<u>IN</u> <u>REALITY</u>"; in lines 7 and 8, strike ": **1**."; and strike beginning with the semicolon in line 8 down through "IMAGE" in line 10.

On page 5, strike in their entirety lines 6 through 9, inclusive; in line 10, strike "(F)" and substitute "(E)"; strike beginning with the colon in line 10 down through "(2)" in line 16; in line 28, strike "(1)"; in the same line, strike the brackets; and strike beginning with "EXCEPT" in line 28 down through "A" in line 29.

On page 6, in lines 1 and 3, in each instance, strike the brackets; in the same lines, strike "(I)" and "(II)", respectively; strike in their entirety lines 5 through 11, inclusive; and strike beginning with "is" in line 12 down through "enacted" in line 16 and substitute "shall take effect June 1, 2024".
