On page 1, in line 7, strike ", taxicab drivers, and transportation network operators"; strike beginning with "; prohibiting" in line 8 down through "suspension" in line 13; in line 17, strike the first comma and substitute "<u>or</u>"; in lines 17 and 18, strike ", taxicab drivers, or transportation network operators"; and strike in their entirety lines 23 through 27, inclusive.

On page 2, strike in their entirety lines 1 through 5, inclusive; and strike in their entirety lines 13 through 31, inclusive.

On page 3, in line 9, after "SERVICE;" insert "<u>OR</u>"; strike beginning with the semicolon in line 11 down through "OPERATOR" in line 13; in line 15, strike "DEVELOP" and substitute "<u>IN CONSULTATION WITH STAKEHOLDERS, DEVELOP</u>"; in lines 19 and 20, strike ", TAXICAB DRIVERS, AND TRANSPORTATION NETWORK OPERATORS"; strike beginning with "INCLUDE" in line 21 down through "DEFINES" in line 23 and substitute "<u>:</u>

(I) INCLUDE A DEFINITION OF";

in line 24, strike "**OFFERS**" and substitute "<u>**OFFER**</u>"; in the same line, strike the comma and substitute "<u>**AND**</u>"; and in line 25, strike ", **TAXICAB DRIVERS**, **AND TRANSPORTATION NETWORK OPERATORS**".

On page 4, in line 2, in each instance, strike "OCTOBER" and substitute "<u>JANUARY</u>"; in the same line, strike "2024" and substitute "<u>2025</u>"; in line 9, strike the

comma and substitute "<u>AND</u>"; in line 15, strike the first comma and substitute "<u>AND</u>"; in lines 10 and 15 and 16, strike ", TAXICAB DRIVERS, AND TRANSPORTATION NETWORK OPERATORS"; strike beginning with "APPROPRIATE" in line 11 down through "HOTLINE" in line 13 and substitute "<u>THE APPROPRIATE LOCAL AGENCIES,</u> <u>INCLUDING THE DESIGNATED REGIONAL NAVIGATOR</u>"; in line 22, after the second comma insert "<u>OR</u>"; in lines 22 and 23, strike ", A TAXICAB DRIVER, OR A TRANSPORTATION NETWORK OPERATOR"; and in line 26, strike "THE" and substitute "<u>TO THE EXTENT PRACTICABLE, THE</u>".
