strike beginning with "] **ENROLLED**" in line 17 down through "**COURSE**" in line 21; after line 21, insert:

"(5) PERFORMS NURSING ASSISTANT TASKS AS A STUDENT WHILE ENROLLED IN AN ACCREDITED NURSING PROGRAM AFTER THE SUCCESSFUL COMPLETION OF THE PORTION OF THE APPROVED NURSING EDUCATION PROGRAM THAT THE BOARD DETERMINES MEETS THE REQUIREMENTS OF AN APPROVED NURSING ASSISTANT TRAINING PROGRAM OR MEDICATION ADMINISTRATION COURSE;";

and in lines 22, 24, 26, and 30, strike "(5)", "(6)", "(7)", and "(8)", respectively, and substitute "(6)", "(7)", "(8)", and "(9)", respectively.

On page 8, in lines 1 and 2, strike the brackets; in line 1, strike "provided that" and substitute "<u>IF</u>"; and in line 4, strike "IN COLLABORATION" and substitute "<u>AFTER</u> <u>CONSULTATION</u>".

On page 10, in line 8, strike "**JUNE 1, 2024**" and substitute "<u>OCTOBER 1, 2025</u>"; in line 22, strike "and [registration] certificate"; and in line 26, after "certificate" insert "<u>AVAILABLE THROUGH THE BOARD'S WEBSITE</u>".

On page 11, in line 2, strike "**JUNE 1, 2024**" and substitute "<u>OCTOBER 1, 2025</u>"; and in line 23, strike "**IN**" and substitute "<u>AFTER</u>".

On page 12, in line 22, strike the bracket; in line 23, strike "geriatric nursing assistants" and substitute "<u>A CERTIFIED NURSING ASSISTANT-I</u>"; in line 24, after "(g)" insert "<u>(1)</u>"; in line 27, strike the bracket; after line 27 insert:

"(2) <u>A NURSING ASSISTANT TRAINING PROGRAM UNDER</u> PARAGRAPH (1) OF THIS SUBSECTION MAY CONTINUE TO OPERATE DURING THE <u>APPROVAL PROCESS.</u>";

and strike in their entirety lines 28 through 31, inclusive.

On page 13, in line 21, strike "October 1, 2024" and substitute "<u>June 1, 2025</u>"; in line 27, before "this" insert "<u>Section 1 of</u>"; in the same line, strike "June" and substitute "<u>October</u>"; in line 28, strike "2024" and substitute "<u>2025</u>"; and after line 28, insert:

"<u>SECTION 4. AND BE IT FURTHER ENACTED</u>, That, except as provided in <u>Section 3 of this Act, this Act shall take effect October 1, 2024.</u>"
