BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Land Use 1-405.A charter county shall enact, adopt, amend, and execute a plan in accordance with this part and Part III of this subtitle.



HOUSING THROUGH THE COUNTY'S HOUSING AND URBAN DEVELOPMENT

- 1 (2) THE HOUSING ELEMENT OF A COMPREHENSIVE PLAN THAT IS
 2 ENACTED OR AMENDED ON OR AFTER JANUARY 1, 2025, SHALL INCLUDE AN
 3 ASSESSMENT OF FAIR HOUSING TO ENSURE THAT THE COUNTY IS AFFIRMATIVELY
 4 FURTHERING FAIR HOUSING.
- 5 (3) ON REQUEST OF A COUNTY, THE DEPARTMENT OF PLANNING, IN
 6 CONSULTATION WITH THE DEPARTMENT OF HOUSING AND COMMUNITY
 7 DEVELOPMENT, SHALL PROVIDE TECHNICAL ASSISTANCE FOR THE PURPOSE OF
 8 DEVELOPING THE HOUSING ELEMENT OF THE COMPREHENSIVE PLAN.
- 9 (4) THIS SUBSECTION DOES NOT REQUIRE A COUNTY TO TAKE, OR 10 PROHIBIT A COUNTY FROM TAKING, A SPECIFIC ACTION TO AFFIRMATIVELY 11 FURTHER FAIR HOUSING.

12 SECTION 2. AND BE IT FURTHER ENACTED, That:

- 13 (a) A charter county that completed or revised an Assessment of Fair Housing 14 under the federal Department of Housing and Urban Development's most recently 15 published Affirmatively Furthering Fair Housing Rule, or an analysis of impediments to 16 fair housing prior to the Affirmatively Furthering Fair Housing Rule, shall incorporate the 17 Assessment of Fair Housing or analysis of impediments into the housing element of the 18 charter county's comprehensive plan, by reference, as described under § 1–407.1 of the 19 Land Use Article, when the charter county amends its comprehensive plan.
- 20 (b) Subsection (a) of this section applies only to a comprehensive plan that is 21 amended on or after January 1, 2024.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2024.
