Property Tax Credits – Public School Employees, Health and Safety Improvements, and Property Used for Local Housing Programs

4 FOR the purpose of authorizing the Mayor and City Council of Baltimore City or the 5 governing body of a county or municipal corporation to grant, by law, a certain 6 property tax credit against the county or municipal corporation property tax imposed 7 on certain residential real property owned by a public school employee under certain 8 circumstances; authorizing the Mayor and City Council of Baltimore City or the 9 governing body of a county or municipal corporation to grant, by law, a certain 10 property tax credit against the county or municipal corporation property tax imposed 11 on an apartment or a condominium building if the owner made health or safety 12 improvements to the building on or after a certain date; authorizing the Mayor and 13 City Council of Baltimore City or the governing body of a county or municipal 14 corporation to grant, by law, a certain property tax credit against the county or 15 municipal corporation property tax imposed on an apartment or a condominium building used on or after a certain date for purposes of a certain local housing 16 17 program; and generally relating to property tax credits for public school employees, 18 health and safety improvements, and property used for local housing programs.
