## Public Employee Relations Act - Alterations

- FOR the purpose of altering certain provisions of the Public Employee Relations Act, including adding the definition of interested employee organization, altering the timing of exclusive representative access to new employees, clarifying the responsibilities of certain deputy directors, and clarifying the process for certain investigations of unfair labor practices; and generally relating to alterations to the Public Employee Relations Act.

- 13 (a) (1) If a party has been charged with engaging in [or has engaged in] an unfair labor practice, the appropriate deputy director shall investigate the charge.
- 15 (2) If the Board, through the deputy director's investigation, finds that 16 probable cause exists to support the charge of an unfair labor practice, the Board shall:
- 17 (i) issue a complaint against the party [stating] STATED IN the 18 [charges] CHARGE; and
- 19 (ii) not less than 15 days after issuing the complaint, issue a notice 20 of a hearing before the Board or the Office of Administrative Hearings.
- 21 (f) The appropriate deputy director shall provide relevant information gathered 22 in the investigation of a charge [or complaint] of unfair labor practices to the Board [and 23 the Office of Administrative Hearings].

- 25 (a) (1) Within 5 days after determining that a valid petition has been submitted under § 22–402 of this subtitle, the Board shall notify interested employee organizations of the pending election petition.
- 28 (2) Within 10 days after determining that a valid petition has been submitted under § 22–402 of this subtitle, the public employer, as appropriate, shall make available to all interested employee organizations reasonable and equivalent means to communicate by mail and in person with each employee in the appropriate bargaining unit for the purpose of soliciting the employee's vote in an election held under this section.
