## 2 Common Ownership Communities – Electric Vehicle Recharging Equipment 3 (Electric Vehicle Recharging Equipment Act of 2024)

- 4 FOR the purpose of altering certain requirements for procedures relating to electric vehicle 5 recharging equipment in a condominium or homeowners association to include 6 equipment for electric bicycles; establishing certain requirements and procedures 7 relating to an application to the governing body of a cooperative housing corporation 8 to install or use electric vehicle recharging equipment; requiring the Department of 9 Housing and Community Development to provide certain information on its common 10 ownership community website; and generally relating to electric vehicle recharging 11 equipment in common ownership communities.

- 7 AFTER THE GOVERNING BODY RECEIVES THE APPLICATION, THE APPLICATION
- 8 SHALL BE DEEMED APPROVED, UNLESS THE DELAY IS THE RESULT OF A
- 9 REASONABLE REQUEST FOR ADDITIONAL INFORMATION.
- 10 (4) THE APPROVAL OR DENIAL OF AN APPLICATION SHALL BE IN
- 11 WRITING.
- 12 (D) (1) THE GOVERNING BODY SHALL APPROVE THE INSTALLATION OF
- 13 ELECTRIC VEHICLE RECHARGING EQUIPMENT IN A PARKING SPACE THAT IS
- 14 SPECIFICALLY DESIGNATED FOR USE BY A PARTICULAR MEMBER IF:
- 15 (I) INSTALLATION:
- 16 DOES NOT UNREASONABLY IMPEDE THE NORMAL USE
- 17 OF AN AREA OUTSIDE THE MEMBER'S PARKING SPACE; AND

- 15 (V) THE COST OF ELECTRICITY ASSOCIATED WITH THE 16 ELECTRIC VEHICLE RECHARGING EQUIPMENT.
- 17 (E) A MEMBER SHALL OBTAIN ANY PERMIT OR APPROVAL FOR ELECTRIC
- 18 VEHICLE RECHARGING EQUIPMENT THAT IS REQUIRED BY THE COUNTY OR
- 19 MUNICIPAL CORPORATION IN WHICH THE COOPERATIVE HOUSING CORPORATION IS
- 20 LOCATED.
- 21 (F) A GOVERNING BODY MAY GRANT A LICENSE FOR UP TO 3 YEARS,
- 22 RENEWABLE AT THE DISCRETION OF THE GOVERNING BODY, ON ANY COMMON
- 23 ELEMENT NECESSARY FOR THE INSTALLATION OF EQUIPMENT OR FOR THE SUPPLY
- 24 OF ELECTRICITY TO ANY ELECTRIC VEHICLE RECHARGING EQUIPMENT.
