2 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

3 (Three-fifths of all the members elected to each of the two Houses concurring), That it be

The State shall be divided by law into legislative districts for the election of members of the Senate and the House of Delegates. Each legislative district shall contain one (1) Senator and three (3) Delegates. [Nothing herein shall prohibit the subdivision of any one or more] EACH of the legislative districts ESTABLISHED for the purpose of electing members of the House of Delegates [into] SHALL CONSIST OF three (3) single—member delegate districts [or one (1) single—member delegate district and one (1) multi—member delegate district].

If a plan has been adopted by the General Assembly by the 45th 9 day after the opening of the regular session of the General Assembly in the second year 10 following every census, the plan adopted by the General Assembly shall become law. If no 11 12 plan has been adopted by the General Assembly for these purposes by the 45th day after 13 the opening of the regular session of the General Assembly in the second year following 14 every census, the Governor's plan presented to the General Assembly shall become law.

23 The Supreme Court of Maryland shall be composed of seven justices, one from the 24First Appellate Judicial Circuit consisting of Caroline, Cecil, Dorchester, Kent, Queen 25Anne's, Somerset, Talbot, Wicomico, and Worcester Counties; one from the Second Appellate Judicial Circuit consisting of Baltimore and Harford Counties; one from the Third 26 27 Appellate Judicial Circuit, consisting of Allegany, Carroll, Frederick, Garrett, Howard, and 28 Washington Counties; one from the Fourth Appellate Judicial Circuit, consisting of Prince 29 George's County; one from the Fifth Appellate Judicial Circuit, consisting of Anne Arundel, 30 Calvert, Charles, and St. Mary's Counties; one from the Sixth Appellate Judicial Circuit, 31 consisting of Baltimore City; and one from the Seventh Appellate Judicial Circuit, 32consisting of Montgomery County. The Justices of the Supreme Court of Maryland shall be residents of their respective Appellate Judicial Circuits. The term of each Justice of the 33 Supreme Court of Maryland shall begin on the date of the [Justice's] JUSTICE'S 34 35 qualification. One of the Justices of the Supreme Court of Maryland shall be designated by 36 the Governor as the Chief Justice. The jurisdiction of the Supreme Court of Maryland shall

be co-extensive with the limits of the State and such as now is or may hereafter be 1 prescribed by law. EXCLUSIVE AMONG THE STATE COURTS, THE SUPREME COURT OF 2 3 MARYLAND SHALL HAVE ORIGINAL JURISDICTION: (1) TO ESTABLISH THE 4 LEGISLATIVE DISTRICT PLAN AND THE CONGRESSIONAL DISTRICT PLAN IN THE EVENT THAT A PLAN IS NOT ENACTED UNDER ARTICLE III, SECTION 5 OF THIS 5 6 CONSTITUTION; AND (2) TO CONSIDER A PETITION SEEKING REVIEW OF THE 7 LEGALITY OF A PLAN TO ESTABLISH LEGISLATIVE OR CONGRESSIONAL DISTRICTS ENACTED UNDER ARTICLE III, SECTION 5 OF THIS CONSTITUTION. It shall hold its 8 sessions in the City of Annapolis at such time or times as it shall from time to time by rule 9 10 prescribe. Its session or sessions shall continue not less than ten months in each year, if 11 the business before it shall so require, and it shall be competent for the justices temporarily 12 to transfer their sittings elsewhere upon sufficient cause. The salary of each Justice of the 13 Supreme Court of Maryland shall be that now or hereafter prescribed by the General 14 Assembly and shall not be diminished during the [Justice's] JUSTICE'S continuance in 15 office. Five of the justices shall constitute a quorum, and five justices shall sit in each case unless the Supreme Court of Maryland shall direct that an additional justice or justices sit 16 17 for any case. The concurrence of a majority of those sitting shall be sufficient for the decision of any cause, and an equal division of those sitting in a case has the effect of affirming the 18 19 decision appealed from if there is no application for reargument as hereinafter provided. In 20 any case where there is an equal division or a three to two division of the Supreme Court 21of Maryland a reargument before the full Court of seven justices shall be granted to the 22losing party upon application as a matter of right.

Immediately after the election, all returns shall be made to the Governor of the vote for and against the proposed amendment, as directed by Article XIV of the Maryland Constitution, and further proceedings had in accordance with Article XIV.
- SECTION 5. AND BE IT FURTHER ENACTED, That Section 2 of this Act is contingent on the passage of Section 1 of this Act, a constitutional amendment, and its ratification by voters of the State.
- SECTION 6. AND BE IT FURTHER ENACTED, That, subject to the provisions of Section 5 of this Act, Section 2 of this Act shall take effect on the proclamation of the Governor that the constitutional amendment, having received a majority of the votes cast at the general election, has been adopted by the people of Maryland.
