A BILL ENTITLED

1 AN ACT concerning

2 Natural Resources – Maryland State Parks – Funds and Plan Alterations

3 FOR the purpose of extending the date by which the Park System Critical Maintenance 4 Fund must be expended; authorizing the Park System Capital Improvements and Acquisition Fund to be used for State projects on lands managed by the Department $\mathbf{5}$ 6 of Natural Resources for public purposes; altering the allowable uses of funds for the 7 initial allocation to the Park System Capital Improvements and Acquisition Fund; 8 authorizing the Great Maryland Outdoors Fund to be used for promoting outdoor 9 environmental education in the State; extending the date by which the Department 10 is required to develop and publish a Comprehensive Long–Range Strategic Plan; and 11 generally relating to the State park system.
