The owner of a motor vehicle, or a lessee of the vehicle under a lease not 5 (a) (1) 6 intended as security, or a director, officer, employee, or partner of a business entity that 7 owns the vehicle may apply to the Administration for the assignment of a special 8 registration number and special registration plates under this section for a vehicle included in one of the following classes: 9 10 A Class A (passenger) vehicle: (i) 11 (ii) A Class E (truck) vehicle with a one ton or less manufacturer's 12 rated capacity; 13 A Class M (multipurpose) vehicle; or (iii) 14 (iv) A Class D (motorcycle) vehicle. To be eligible for a special registration described under subsection 15 **(4)** 16 (c)(2)(iii) of this section, an applicant shall provide proof that is satisfactory to the 17 Administration that the applicant is a recipient of the U.S. Department of Defense Gold 18 Star OR NEXT OF KIN LAPEL BUTTON for surviving spouses, parents, and next of kin of members of the armed forces who lost their lives [in combat] WHILE SERVING ON ACTIVE 19 20 DUTY OR WHILE ASSIGNED TO A RESERVE OR NATIONAL GUARD UNIT IN A DRILL 21 STATUS. 22 (b) (1) [In] EXCEPT AS PROVIDED IN PARAGRAPH (4) OF THIS 23SUBSECTION, IN addition to the annual registration fee otherwise required under this 24title, an owner of a vehicle assigned a special registration under this section shall pay a fee 25as determined by the Administration each time new registration plates are issued for the 26 vehicle. 27 (2) The fee shall be calculated to: 28 Recover the costs incurred by the Administration in carrying out (i) 29the provisions of this section; and
