2 **Cannabis Reform – Alterations**

3 FOR the purpose of altering the best practices that the Alcohol, Tobacco, and Cannabis
4 Commission is required to develop; altering the membership of the Commission;
5 making alterations and clarifications related to the duties of the Commission, the
6 Office of Social Equity, the Advisory Board on Medical and Adult-Use Cannabis, and
7 the Maryland Cannabis Administration; altering the composition of the Advisory
8 Board; requiring the ~~Governor to appoint the chair of the~~ Advisory Board to elect a
9 chair and removing the Director of the Administration as chair; authorizing
10 processors to provide cannabis to cannabis licensees; requiring the Administration
11 to register and regulate cannabis nurseries; authorizing the Administration to
12 impose certain penalties on a cannabis license or registration for the violation of
13 certain laws and regulations; requiring the Administration rather than the
14 Comptroller to administer the Cannabis Regulation and Enforcement Fund; altering

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
22 That the Laws of Maryland read as follows:

23 **Article – Alcoholic Beverages and Cannabis**

24 1–101.

25 (a) In this article the following words have the meanings indicated.

26 (d) (1) “Cannabis” means the plant Cannabis sativa L. and any part of the
27 plant, including all derivatives, extracts, cannabinoids, isomers, acids, salts, and salts of
28 isomers, whether growing or not, with a delta–9–tetrahydrocannabinol concentration
29 greater than 0.3% on a dry weight basis.

30 (2) “Cannabis” includes cannabis products, **SEEDS, SEEDLINGS,**
31 **IMMATURE PLANTS, AND CLONES.**

32 (3) “Cannabis” does not include hemp or hemp products, as defined in §
33 14–101 of the Agriculture Article.

1 (a) To the extent that a statement of a general rule of law conflicts or is
 2 inconsistent with an exception or a qualification applicable to a special area, particular
 3 person, or set of circumstances, the exception or qualification prevails.

4 (b) A provision in Division II of this article prevails over a conflicting or
 5 inconsistent provision in Division I of this article or a provision in the Tax – General Article
 6 relating to alcoholic beverages.

7 (c) A provision in Division III of this article prevails over a conflicting or
 8 inconsistent provision in Division I OR DIVISION II of this article or a provision in the Tax
 9 – General Article relating to cannabis.

11 (a) (1) The Commission consists of [seven] FIVE members to be appointed by
 12 the Governor with the advice and consent of the Senate.

13 (3) Of the Commission members:

14 (i) one shall be knowledgeable and experienced in public health
 15 matters;

16 (ii) one shall be knowledgeable and experienced in law enforcement
 17 matters;

18 (iii) one shall be knowledgeable and experienced in the alcoholic
 19 beverages industry; AND

20 (iv) [one shall have expertise in cannabis research and policy;

21 (v) one shall have expertise in alcohol and tobacco policy; and

22 (vi) two shall be members of the public who are knowledgeable and
 23 experienced in fiscal matters and shall have substantial experience:

24 1. as an executive with fiduciary responsibilities in charge of
 25 a large organization or foundation;

26 2. in an academic field relating to finance or economics; or

27 3. as an accountant, an economist, or a financial analyst.

29 The Commission shall develop best practices for:

1 (8) the development of a public health impact statement for all changes to
2 the State alcoholic beverages laws; AND

3 (9) ensuring that:

4 (i) all license holders, managers, and servers receive certification
5 from an approved alcohol awareness program; and

6 (ii) at least one employee who is certified in an alcohol awareness
7 program be on the licensed premises at all times when alcoholic beverages are served[;

8 (10) regulating the cannabis industry and implementing public health
9 measures relating to cannabis; and

10 (11) regulating, to the extent possible, medical and adult-use cannabis in a
11 similar manner].

13 (d) The Office of Social Equity shall:

14 (5) provide recommendations to the [Commission] MARYLAND
15 CANNABIS ADMINISTRATION on regulations related to:

16 (i) diversity; and

17 (ii) social equity applications;

18 (e) (1) On or before March 1 each year, the Office of Social Equity shall produce
19 and make publicly available a report on how the funds in the Community Reinvestment
20 and Repair Fund under § 1-322 of this subtitle were allocated during the immediately
21 preceding calendar year.

22 (2) The report shall also be submitted to the General Assembly in
23 accordance with § 2-1257 of the State Government Article.

24 (3) THE OFFICE MAY REQUEST INFORMATION FROM POLITICAL
25 SUBDIVISIONS AND ENTITIES RECEIVING DISTRIBUTIONS FROM THE FUND TO
26 ASSIST WITH THE COMPLETION OF THE REPORT.

27 (f) (1) On or before November 1 [each year] EVERY 2 YEARS, BEGINNING IN
28 2024, the Office of Social Equity shall solicit public input on the uses of the funds in the
29 Community Reinvestment and Repair Fund under § 1-322 of this subtitle.

30 ~~(g)~~ (2) On or before December 15 ~~each year~~ EVERY 2 YEARS, BEGINNING IN
31 2024, the Office of Social Equity shall publish a review of the input received under

1 paragraph (1) of this subsection on a publicly accessible part of the [Commission's]

3 **(3) THE OFFICE SHALL INCLUDE IN THE REVIEW INFORMATION ON**
4 **HOW THE FUNDS RECEIVED FROM THE FUND WERE SPENT DURING THE**
5 **IMMEDIATELY PRECEDING 2 CALENDAR YEARS.**

20 (d) **(1)** The Advisory Board consists of[:

21 (1) the Director of the Maryland Cannabis Administration, who shall serve
22 as Chair of the Advisory Board; and

23 (2)] the following members, appointed by the Governor with the advice and
24 consent of the Senate:

25 (i) three members that have substantial experience in one or more
26 of the following:

27 1. cannabis law, science, or policy;

28 2. public health or health care;

29 3. agriculture;

30 4. finance; or

31 5. addiction treatment;

- 1 (ii) one academic researcher with at least 5 years of experience in
2 social or health equity;
- 3 (iii) one representative of an independent testing laboratory
4 registered under § 36–408 of this article;
- 5 (iv) two representatives who hold a standard grower license under §
6 36–401 of this article;
- 7 (v) two representatives who hold a standard processor license under
8 § 36–401 of this article;
- 9 (vi) two representatives who hold a standard dispensary license
10 under § 36–401 of this article;
- 11 (vii) two representatives who hold a micro grower license under §
12 36–401 of this article;
- 13 (viii) two representatives who hold a micro processor license under §
14 36–401 of this article;
- 15 (ix) two representatives who hold a micro dispensary license under §
16 36–401 of this article;
- 17 (x) one representative who holds an incubator space license under §
18 36–401 of this article;
- 19 (xi) one representative who holds an on–site consumption license
20 under § 36–401 of this article;
- 21 (xii) one representative of an organization that advocates on behalf of
22 patients who engage in the medical use of cannabis;
- 23 (xiii) one representative of an organization that advocates on behalf of
24 consumers who engage in the adult use of cannabis; and
- 25 (xiv) one health care provider who is registered to certify patients to
26 obtain medical cannabis under § 36–301 of this article.

27 **(2) ~~FROM AMONG THE MEMBERS OF THE~~ THE ADVISORY BOARD, THE**
28 **~~GOVERNOR SHALL APPOINT~~ ELECT A CHAIR FROM AMONG ITS MEMBERS.**

29 (e) The President of the Senate and the Speaker of the House may recommend to
30 the Governor a list of individuals for appointment to the Advisory Board.

31 (f) (1) The term of a member of the Advisory Board is 4 years.

1 (2) At the end of a term, a member continues to serve until a successor is
2 appointed and qualifies.

3 (3) An appointed member may not serve more than two full terms.

4 (4) The positions for members appointed under subsection [(d)(2)(vii)
5 through (xi)] **(D)(1)(VII) THROUGH (XI)** of this section become effective when the first
6 licenses are issued under those respective license types.

7 (g) An appointed member of the Advisory Board must be:

8 (1) at least 25 years old;

9 (2) a resident of the State who has resided in the State for at least the
10 immediately preceding 5 years before the appointment; and

11 (3) a registered voter of the State.

12 (h) The Advisory Board shall establish at least two subcommittees to focus on
13 medical and adult-use cannabis.

14 (i) To the extent practicable and consistent with federal and State law, the
15 membership of the Advisory Board shall reflect the racial, ethnic, and gender diversity of
16 the State.

17 **(J) THE MARYLAND CANNABIS ADMINISTRATION SHALL PROVIDE STAFF**
18 **FOR THE ADVISORY BOARD.**

20 (a) (1) There is a Community Reinvestment and Repair Fund.

21 (7) **(I) The State Treasurer shall invest the money of the Fund in the**
22 **same manner as other State money may be invested.**

23 **(II) ANY INTEREST EARNINGS OF THE FUND SHALL BE**
24 **CREDITED TO THE GENERAL FUND OF THE STATE.**

25 (8) No part of the Fund may revert or be credited to:

26 (i) the General Fund of the State; or

27 (ii) any other special fund of the State.

1 **(b) (2) [(i)]** Subject to the limitations under subsection (a)(6) of this section,
2 each county shall adopt a law establishing the purpose for which money received from the
3 Fund may be used.

4 **[(ii)** On or before December 1 every 2 years, beginning in 2024, each
5 political subdivision that receives funds from the Fund under paragraph (1) of this
6 subsection shall submit a report to the Governor and, in accordance with § 2-1257 of the
7 State Government Article, the Senate Budget and Taxation Committee and the House
8 Appropriations Committee on how funds received from the Fund were spent during the
9 immediately preceding 2 fiscal years.]

11 (a) In this title the following words have the meanings indicated.

12 (h) “Cannabis licensee” means a business licensed by the Administration to
13 operate in the cannabis industry.

14 **(H-1) “CANNABIS NURSERY” MEANS A BUSINESS THAT PROVIDES CANNABIS**
15 **SEEDS, SEEDLINGS, IMMATURE PLANTS, OR CLONES TO A CANNABIS BUSINESS.**

16 (j) “Cannabis registrant” means an independent testing laboratory, a
17 transporter, a security guard company, a waste disposal company, **A CANNABIS NURSERY**,
18 and any other type of cannabis business registered under this title and authorized by the
19 Administration.

20 (aa) “Ownership interest” means a direct or indirect equity interest in a cannabis
21 licensee, including in its **PROFITS, REVENUES**, shares, or stock.

22 (dd) “Processor” means an entity licensed under this title that:

23 (1) transforms cannabis into another product or an extract and packages
24 and labels the cannabis product; and

25 (2) is authorized by the Administration to provide cannabis to [licensed
26 dispensaries] **CANNABIS LICENSEES** and registered independent testing laboratories.

27 36-202.

28 (a) The Administration shall:

29 (1) develop and maintain a seed-to-sale tracking system that tracks
30 cannabis from either the seed or immature plant stage until the cannabis is sold to a
31 patient, caregiver, or consumer;

1 (2) conduct financial and criminal background investigations of any person
2 who submits an application for a cannabis license or a cannabis licensee, as required under
3 this title;

4 (3) develop a process for consumers and qualifying patients to purchase
5 clones and seeds, seedlings, stalks, roots, and stems of the cannabis plant for cultivation in
6 accordance with § 5–601.2 of the Criminal Law Article;

7 (4) solicit, evaluate, and issue or deny applications for cannabis licenses
8 and cannabis registrations, including:

9 (i) licenses to operate a cannabis business in accordance with this
10 title; and

11 (ii) registration for independent testing laboratories, transporters,
12 security guard companies, [and] waste disposal companies, **AND CANNABIS NURSERIES**;

13 (5) award or deny:

14 (i) a license to operate a cannabis business in accordance with this
15 title; and

16 (ii) registration to independent testing laboratories, transporters,
17 security guard companies, waste disposal companies, **CANNABIS NURSERIES**, and any
18 other type of cannabis business authorized by the Administration;

19 (6) conduct announced and unannounced inspections of any business
20 licensed or registered under this title to ensure compliance with this title;

21 (7) after a determination that a violation of this title or a regulation
22 adopted under this title has occurred, suspend, fine, restrict, or revoke cannabis licenses
23 and cannabis registrations, whether active, expired, or surrendered, or impose any other
24 penalty authorized by this title or any regulation adopted under this title;

25 (8) (i) give notice and hold a hearing in accordance with Title 10,
26 Subtitle 2 of the State Government Article, for any:

27 1. contested cannabis license or registration denial; or

28 2. violation of this title or any regulation adopted under this
29 title;

30 (ii) administer oaths in a proceeding under this section; and

31 (iii) subject to subsection (b)(3) of this section, allow the person
32 against whom the action is contemplated to be represented at the hearing by counsel;

1 (9) adopt regulations necessary to carry out its duties under this title; and

2 (10) perform any other power authorized or duty required under this title or
3 any other provision of State law.

4 (b) The Administration may:

5 (1) issue a subpoena for the attendance of a witness to testify or the
6 production of evidence in connection with:

7 (i) any disciplinary action under this title; or

8 (ii) any investigation or proceeding initiated for an alleged violation
9 of this title;

10 (2) delegate the hearing authority authorized under subsection (a)(8) of
11 this section to an employee within the Administration; [and]

12 (3) if, after due notice, the person against whom a disciplinary action is
13 contemplated does not appear at a hearing, hear and determine the matter; AND

14 (4) AFTER A HEARING UNDER THIS SUBSECTION, FINE A CANNABIS
15 LICENSEE OR SUSPEND, RESTRICT, OR REVOKE A CANNABIS LICENSE OR A
16 CANNABIS REGISTRATION FOR A VIOLATION OF:

17 (I) THIS TITLE OR A REGULATION ADOPTED UNDER THIS TITLE;
18 OR

19 (II) ANY OTHER STATE LAW OR REGULATION RELATED TO
20 CANNABIS OR THE OPERATIONS OF A CANNABIS BUSINESS OR REGISTRANT.

22 (b) There is a Cannabis Regulation and Enforcement Fund.

23 (d) The [Comptroller] ADMINISTRATION shall administer the Fund [at the
24 direction of the Administration].

25 (j) (1) On or before March 15 each year, the [Comptroller] ADMINISTRATION
26 shall publish on its website a detailed report on revenue distributed to and expenditures
27 from the Fund.

28 36–302.

29 (g) A qualifying patient may NOT possess [up to:

1 (1) 120 grams of usable cannabis; or

2 (2) 36 grams of delta-9-tetrahydrocannabinol (THC) in the case of a
3 cannabis-infused product] **MORE THAN THE AMOUNT OF CANNABIS OR**
4 **CANNABIS-INFUSED PRODUCT THAT IS AUTHORIZED IN THE WRITTEN**
5 **CERTIFICATION OF THE PATIENT.**

6 36-401.

7 (c) (1) A standard license authorizes the holder of the license:

8 (i) for growers, to operate more than 10,000 square feet, but not
9 more than 300,000 square feet, of indoor canopy or its equivalent, as calculated by the
10 Administration;

11 (ii) for processors, to process more than [1,000] **2,000** pounds of
12 cannabis per year, as calculated by the Administration; and

13 (iii) for dispensaries, to operate a store at a physical location that
14 sells cannabis or cannabis products.

15 (2) A micro license authorizes the holder of the license:

16 (i) for growers, to operate not more than 10,000 square feet of indoor
17 canopy or its equivalent, as calculated by the Administration;

18 (ii) for processors, to process not more than [1,000] **2,000** pounds of
19 cannabis per year, as calculated by the Administration; and

20 (iii) for dispensaries, to operate a delivery service that sells cannabis
21 or cannabis products without a physical storefront, provided that the licensee employs not
22 more than 10 employees.

23 (e) (1) This subsection applies to all licenses, including licenses converted
24 under subsection (b)(1)(ii) of this section.

25 (2) Subject to paragraph (3) of this subsection, a person may have an
26 ownership interest in or control of, including the power to manage and operate:

27 (i) for standard licenses and micro licenses:

28 1. one grower licensee;

29 2. one processor licensee; and

30 3. not more than four dispensary licensees;

1 (ii) for incubator space licenses, not more than two licensees; and

2 (iii) for on-site consumption licenses, not more than two licensees.

3 (3) (i) A person who owns or controls an incubator space licensee or an
4 on-site consumption licensee may not own or control any [other] cannabis licensee LISTED
5 UNDER PARAGRAPH (2)(I) OF THIS SUBSECTION.

6 (ii) The Administration shall adopt regulations limiting a person or
7 fund from acquiring a nonmajority ownership interest in multiple cannabis businesses
8 beyond the limitations established under this subsection.

9 (4) The restrictions in paragraph (2) of this subsection do not apply to a
10 person or an entity who holds an ownership interest only as a passive investor.

11 (g) Notwithstanding any provisions of this title, the holder of a dispensary license
12 issued by the Natalie M. LaPrade Medical Cannabis Commission who converts the license
