18 19 20 21 22 23 24 25 26	(e) (1) A certificate alleging that the violation of this subtitle occurred and the requirements under subsection (b) of this section have been satisfied, sworn to, or affirmed by a duly authorized law enforcement officer employed by or under contract with an agency OR, FOR A MUNICIPAL CORPORATION THAT DOES NOT MAINTAIN A POLICE FORCE, A TECHNICIAN EMPLOYED BY AN AGENCY , based on inspection of recorded images produced by a speed monitoring system, shall be evidence of the facts contained in the certificate and shall be admissible in a proceeding alleging a violation under this section without the presence or testimony of the speed monitoring system operator who performed the requirements under subsection (b) of this section.
27 28 29	(2) If a person who received a citation under subsection (d) of this section desires the speed monitoring system operator to be present and testify at trial, the person shall notify the court and the State in writing no later than 20 days before trial.

30 (3) Adjudication of liability shall be based on a preponderance of evidence.
