# 2 Criminal Law – Visual Surveillance With Prurient Intent – Private Place and 3 Minor Victim

FOR the purpose of prohibiting a person from conducting visual surveillance with prurient
intent of an individual located in a residence or place of private use or
accommodation without the consent of the individual; altering the penalties for the
crime of visual surveillance with prurient intent by use of a camera if the victim was
a minor at the time of the offense and the offender is at least a certain number of
years older than the victim; and generally relating to the crime of visual surveillance
with prurient intent.

# SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

1 (e) (1) An individual who was under visual surveillance in violation of this 2 section has a civil cause of action against any person who conducted or procured another to 3 conduct the visual surveillance.

4 (2) In an action under this subsection, the court may award actual damages 5 and reasonable attorney's fees.

6 (f) This section does not affect any legal or equitable right or remedy otherwise 7 provided by law.

8 (g) This section does not affect the application of § 3–901 of this subtitle.

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 10 October 1, 2024.
