That the Laws of Maryland read as follows: 13 14 Article - State Finance and Procurement SUBTITLE 9. STATE CONTRACTS. 15 2-901. 16

- 17 (A) IN THIS SECTION, "STATE CONTRACT" MEANS ANY AGREEMENT 18 ENTERED INTO BY THE STATE.
- 19 (B) EXCEPT AS REQUIRED BY STATE OR FEDERAL LAW, A STATE CONTRACT 20 MAY NOT INCLUDE:
- 21 (1) A PROVISION THAT REQUIRES THE STATE TO INDEMNIFY, 22 DEFEND, OR HOLD HARMLESS ANOTHER PERSON;



- 1 (2) A PROVISION BY WHICH THE STATE AGREES TO BINDING
- 2 ARBITRATION OR ANY OTHER BINDING EXTRAJUDICIAL DISPUTE RESOLUTION
- 3 PROCESS;
- 4 (3) A PROVISION THAT NAMES A JURISDICTION OR VENUE FOR ANY

- 18 (II) MAY BE UNILATERALLY CHANGED BY THE OTHER PARTY; OR
- 19 (III) IS ELECTRONICALLY ACCEPTED BY A STATE EMPLOYEE
- 20 WITHOUT AUTHORITY;
- 21 (6) A PROVISION THAT PROVIDES FOR A PERSON OTHER THAN THE
- 22 ATTORNEY GENERAL OF MARYLAND TO SERVE AS LEGAL COUNSEL FOR THE STATE,
- 23 UNLESS PROVIDED UNDER § 6–106 OF THE STATE GOVERNMENT ARTICLE;
- 24 (7) A PROVISION THAT IS INCONSISTENT WITH THE STATE'S
- 25 OBLIGATIONS UNDER TITLE 3 OR 4 OF THE GENERAL PROVISIONS ARTICLE;
- 26 (8) A PROVISION PROHIBITED UNDER § 7–237 OF THIS ARTICLE;
- 27 (9) A PROVISION FOR AUTOMATIC RENEWAL THAT OBLIGATES THE
- 28 STATE TO ALLOCATE FUNDING IN SUBSEQUENT FISCAL YEARS; OR
- 29 (10) A PROVISION THAT LIMITS THE STATE'S ABILITY TO RECOVER THE
- 30 COST OF A REPLACEMENT CONTRACTOR.

- 1 (C) IF A STATE CONTRACT CONTAINS A PROVISION LISTED UNDER 2 SUBSECTION (B) OF THIS SECTION, THE PROVISION IS VOID AB INITIO AND THE 3 CONTRACT CONTAINING THAT PROVISION SHALL BE ENFORCEABLE AS IF IT DID NOT 4 CONTAIN THE PROVISION.
  - (D) A STATE CONTRACT THAT CONTAINS A PROVISION LISTED UNDER SUBSECTION (B) OF THIS SECTION SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH STATE LAW, NOTWITHSTANDING ANY TERM OR CONDITION TO THE CONTRARY IN THE CONTRACT.

- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply only prospectively and may not be applied or interpreted to have any effect on or application to any State contract executed before the effective date of this Act or to the renewal or extension of a State contract executed before the effective date of this Act.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2024.
