BY adding to Article - Election Law Section 4-206 Annotated Code of Maryland (2022 Replacement Volume and 2023 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Election Law 4-206.THIS SECTION APPLIES ONLY TO THE PROCESS OF FILLING A VACANCY (A) IN THE OFFICE OF SENATOR OR DELEGATE IN THE GENERAL ASSEMBLY UNDER ARTICLE III, § 13 OF THE MARYLAND CONSTITUTION.
