A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore County – Nuisance Actions – Community Association**

3 FOR the purpose of altering the definitions of “community association” and “local code
4 violation” to authorize community associations to seek judicial relief for nuisance
5 abatement in Baltimore County; repealing a provision of law requiring a certain
6 court to determine the amount and conditions of a bond filed by a community
7 association in a certain nuisance action; and generally relating to the right of
8 community associations to seek judicial relief for nuisance abatement in Baltimore
9 County.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Real Property**

18 14–125.

19 (a) (1) In this section the following words have the meanings indicated.

20 (2) **(I)** “Community association” means a Maryland nonprofit
21 ASSOCIATION, corporation, OR OTHER ORGANIZATION that IS:

22 [(i) Is comprised of at least 20% of the total number of households as

1 members, with a minimum membership of 25 households, of a local community that
 2 consists of 40 or more individual households as defined by specific geographic boundaries
 3 in the bylaws or charter of the community association;]

4 **1. COMPOSED OF RESIDENTS OF A COMMUNITY**
 5 **DEFINED BY SPECIFIC GEOGRAPHIC BOUNDARIES IN THE BYLAWS OR CHARTER OF**
 6 **THE COMMUNITY ASSOCIATION AND WITHIN WHICH A NUISANCE IS LOCATED;**

7 [(ii) Requires, as a condition of membership, the payment of
 8 monetary dues at least annually;]

9 [(iii) **2. [Is operated] OPERATED** primarily for the promotion of
 10 social welfare and general neighborhood improvement and enhancement;

11 [(iv) Has been in existence for at least 1 year when it files suit under
 12 this section;]

13 [(v) **1.] 3. [Is exempt] EXEMPT** from taxation under § 501(c)(3) or
 14 **(4) OR § 528** of the Internal Revenue Code; [or

15 **2. Has been included for a period of at least 1 year prior to**
 16 **bringing an action under this section in the “Directory of Organizations in Baltimore**
 17 **County” that is published by the Baltimore County Public Library;] and**

18 [(vi) **4. [Is] INCORPORATED AND** in good standing **WITH THE**
 19 **STATE DEPARTMENT OF ASSESSMENTS AND TAXATION.**

20 **(II) “COMMUNITY ASSOCIATION” INCLUDES A MARYLAND**
 21 **NONPROFIT ASSOCIATION, CORPORATION, OR OTHER ORGANIZATION THAT:**

22 **1. MEETS THE REQUIREMENTS OF AN INDIVIDUAL**
 23 **COMMUNITY ASSOCIATION UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH; AND**

24 **2. REPRESENTS TWO OR MORE INDIVIDUAL COMMUNITY**
 25 **ASSOCIATIONS.**

26 **(3) (I) “Local code violation” means a violation under ARTICLE 13,**
 27 **Title [22.] 7. “Nuisances” OR, EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS**
 28 **PARAGRAPH, ARTICLE 35, “BUILDING AND HOUSING” of the Baltimore County Code**
 29 **[1988] 2015.**

30 **(II) “LOCAL CODE VIOLATION” DOES NOT INCLUDE A**
 31 **VIOLATION UNDER ARTICLE 35, TITLE 4. “RENT ESCROW LAW” OF THE BALTIMORE**
 32 **COUNTY CODE 2015.**

1 (4) "Nuisance" means, within the boundaries of the community
2 represented by the community association, an act or condition created, performed, or
3 maintained on private property that constitutes a local code violation and that:

4 (i) Negatively impacts the well-being of other residents of the
5 neighborhood; and

6 (ii) 1. Is injurious to public health, safety, or welfare of
7 neighboring residents; or

8 2. Obstructs the reasonable use of other property in the
9 neighborhood.

10 (b) This section only applies to a nuisance located within the boundaries of
11 Baltimore County.

12 (c) (1) A community association may seek injunctive and other equitable relief
13 in the Circuit Court for Baltimore County for abatement of a nuisance upon showing that:

14 (i) The notice requirements under paragraphs (2) and (3) of this
15 subsection have been satisfied; and

16 (ii) The nuisance has not been abated.

17 (2) (i) An action may not be brought under this section based on a
18 nuisance until 60 days after the community association gives notice of the violation and of
19 the community association's intent to bring an action under this section by certified mail,
20 return receipt requested, to the County Code enforcement agency.

21 (ii) An action under this section may not be brought if the County
22 Code enforcement agency has filed an action for equitable relief from the nuisance.

23 (3) (i) An action may not be brought under this section until 60 days
24 after the tenant, if any, and owner of record receive notice by certified mail, return receipt
25 requested, from the community association that a nuisance exists and that legal action may
26 be taken if the nuisance is not abated.

27 (ii) The notice shall specify:

28 1. The nature of the alleged nuisance;

29 2. The date and time of day the nuisance was first
30 documented;

31 3. The location on the property where the nuisance is
32 allegedly occurring; and

1 4. The relief sought.

2 (iii) In filing a suit under this section, an officer of the community
3 association shall certify to the court:

4 1. What steps the community association has taken to satisfy
5 the notice requirements under this subsection; and

6 2. That each condition precedent to the filing of an action
7 under this section has been met.

8 [(4) The court shall determine in what amount and under what conditions,
9 if any, a bond shall be filed by a community association in an action for relief under this
10 section.]

11 (d) A political subdivision of the State or any agency of a political subdivision is
12 not subject to any action brought under this section or an action resulting from an action
13 brought under this section against a private property owner.

14 (e) (1) Subject to paragraph (2) of this subsection, this section may not be
15 construed to abrogate any equitable or legal right or remedy otherwise available under the
16 law to abate a nuisance.

17 (2) This section may not be construed as granting standing for an action:

18 (i) Challenging any zoning, development, special exception, or
19 variance application or approval;

20 (ii) In which the alleged nuisance consists of:

21 1. A condition relating to lead paint;

22 2. An interior physical defect of a property, except in
23 situations that present a threat to neighboring properties; or

24 3. A vacant dwelling that is maintained in a boarded
25 condition, free from trash and debris, and secure against trespassers and weather entry;

26 (iii) Involving any violation of alcoholic beverages laws under the
27 Alcoholic Beverages and Cannabis Article; or

28 (iv) Involving any matter in which a certificate, license, permit, or
29 registration is required or allowed under the Environment Article.

30 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
31 October 1, 2024.
